Groton Robotics Teams Heading to Council Bluffs & Dallas for an Exciting End of Season!

With the State Robotics championship now completed, the Groton Robotics program is typically cleaning and getting ready for the 25'-26' season ahead. Not this year!

Team Galaxy, 9050 E: Axel Warrington & Corbin Weismantel, Co-Lead; Illyanna Dallaire & Ayce Warrington are heading to the U.S Open Robotics Tournament held this weekend in Council Bluffs, Iowa. This tournament, typically reserved for our graduating seniors as a congratulations for their Robotics career at Groton, is an open event where Robotics teams from around the world bring their robots, with modifications allowed of parts outside of standard VEX parts, to compete. Teams from around the world will be in attendance and with our 2 seniors leaving, Groton Robotics wishes Good Luck to Axel & Corbin.

The senior team members of 9050F – Gladiators: Garrett Schultz, Lead; Jameson Penning & Haden Harder have received a formal invitation to attend the 2025 VEX Robotics World Championships. This invitation came as a very much surprise to the Gladiators! The only way to receive this is to win the SD State Championship, in which they came in runner-up with Mitchell. However, after the tournament it was determined that one of the winning teams qualified in 2 categories. Mitchell was next in line – but declined. After Team Lead Garrett Schultz started receiving messages from fellow robotics students around the state stating "Don't tear down your robot yet", they received the call and accepted the invitation.

The VEX World Championships will be held on May 6th-8th in Dallas, Texas. 75 countries will be participating and competitions will be held amongst 800 teams. We believe the last time a Groton Robotics team participated in Worlds was over 10 years ago.

Groton council awards garbage hauling contract, discusses wastewater project

The Groton City Council awarded a three-year garbage hauling contract and reviewed funding for its upcoming wastewater project, both decisions that will bring an increase to residents' utility bills in the months ahead.

The city received two bids for a three-year garbage hauling contract, one from current contractor Heartland Waste and the other from A-1 Sanitation.

The A-1 Sanitation bid was \$8,094 per month to pick up one time per week for residences. Residents would have one 95-gallon container. It would equate to \$13.49 per residence per month for about 600 residences.

Heartland Waste Management's bid totaled \$19.44 per residence per month, though president/owner Kent Mauck said the two bids were not "comparing apples to apples."

Heartland has done things a little different in the last few years to help preserve city streets, he said. During times when the road bases are softer due to frost thawing,

Heartland has crews bring lighter trucks that require more manpower, but do less damage to the streets. It's a big difference from what the other companies provide.

"They would choke at the way we do it, bringing in multiple people and a pickup and cleaning up the community," he said.

Heartland Waste's bid comes with a price increase from about \$16 to more than \$19 per residence per month. With that rate increase, the city would have to raise its rate on the utility bill.

Council members said they appreciated Heartland not driving heavy trucks on city streets during spring thaw periods. They also mentioned residents didn't seem like they want to change.

"It ain't broke..." Councilman Brian Bahr said. "...I still think Heartland is the way to go, even though it's a little more money."

Bahr added he likes that Heartland even picks up garbage bags or items left next to trash cans, while A-1 Sanitation's bid only includes one can per residence. The council awarded the bid to Heartland for a three-year term.

In addition, the council examined funding for the city's upcoming wastewater project.

Ted Dickey with Northeast Council of Governments told the council about a recent South Dakota Department of Agriculture and Natural Resources meeting where staff reviewed water project funding applications, including one from Groton to help with emergency discharges, infiltration and permit violations.

The proposed project includes replacing a lift station, increasing the force main size and creating a new wastewater collection cell. The cost totals \$6.587 million.

The state department funding recommendation included a \$4.587 million loan from the Clean Water State Revolving Fund at 3.75 percent for 30 years and an up to \$2 million grant.

To receive that loan and grant, though, the city will need to increase rates by either \$30.30 or \$35.30 depending on the city's rate structure, Dickey said.

Weekly Vikings Roundup

The Minnesota Vikings underwent a signifi- cant change on the defensive side of the ball last offseason, and no move was bigger than the team letting Danielle Hunter walk in free agency. Hunter spent his first eight seasons in Minnesota, accumulating 87.5 sacks and making the Pro Bowl four times (which is es- pecially impressive considering he only started one game in his first two seasons). Hunter, unfortunately, was more of a 4-3 defensive end, and when the Vikings switched to a 3-4 defense, they had to find players who better fit the scheme. And so, in an effort to replace Hunter, the Vikings signed two lesser-known players in free agency last year, Jonathan

“You’re not going to need to have the money immediately, but at some point or another, a year down the line, you’re going to have to be at that rate,” he said. “In order to close the loan, we’re going to need to have your rates up and set aside.”

The next steps would be to sign a contract with an engineer to draw up designs, Dickey said. However, if the council’s not ready to do that yet, a decision can be pushed back a month without hurting the funding.

The council asked representatives from IMEG and the Northeast Council of Govern- ments to attend the May 6 council meeting, which may be moved to the Community Center to allow for more people to attend.

- City offices will be closed April 18 and 21 for Good Friday and Easter Monday.
- The council renewed three malt bev- erage licenses for 2025-2026, including ones for MJ’s Sinclair, Ken’s Food Fair and Dollar General.
- The council approved a special event alcoholic beverage license for the April 12 Fire- man’s Fun Night at 305 East Railroad Avenue.
- After receiving no sealed bids for exte- rior painting of City Hall, the council decided to hold off on the project to save funds.

Greenard and Andrew Van Ginkel.

Jonathan Greenard was a third-round pick by the Houston Texans and played there for four seasons before coming to Minnesota. In his first year with the Vikings, Greenard racked up 12 sacks and made his first Pro Bowl. He was the 2024 week three defensive player of the week in the NFC and the defensive player of the month in November last year. He will be 28 when the season starts and should be a main piece of the Vikings’ defense next season.

Andrew Van Ginkel was an under-the-radar acquisition last offseason when he signed with the Vikings. He was a fifth-round pick by the Miami Dolphins in 2019 and spent his first five seasons in the league there. He was coming off the best season of his career with six sacks in 2023. In 2024 with the Vikings, AVG had 11.5 sacks and made his first Pro Bowl. He was also named the Week 16 NFC Defensive Player of the Week.

Dallas Turner was a first-round pick last year, but he didn’t see the field as much as most people anticipated. However, that’s not his fault, since the Vikings had Greenard and AVG playing at Pro Bowl levels. Tuner played in 16 games last season but didn’t start any of them. However, he started seeing the field more as the season progressed, and that should carry over into 2024.

Besides Greenard, Avg, and Turner, the Vi- kings had Patrick Jones Jr., Gabriel Murphy, Bo Richter, and Jihad Ward get some playing time at outside linebacker last year. Patrick Jones Jr. was the most impressive of the group, and he turned a productive 2024 into a new contract with the Carolina Panthers this offseason. Gabriel Murphy and Bo Richter are still on the roster, while Jihad Ward is a free agent and waiting to sign with a new team soon.

At inside linebacker, the Vikings’ 2024 start- ers were Blake Cashman and Ivan Pace Jr., and both will be back for the 2025 season. However, both players have injury concerns (Cashman started 14 games last season while Pace only started 10). To add some depth to the iLB position, the Vikings brought back a familiar face this offseason when they signed Eric Wilson. Also on the roster is Brian Asa- moah, who will battle it out with Wilson for the primary backup this upcoming season. While Cashman and Pace are good players when they are on the field, I wouldn’t be surprised to see the Vikings bring in more depth, either through free agency or the draft.

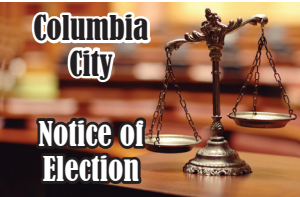

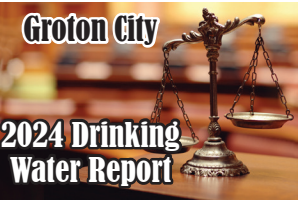

Secretary's Award

The City of Groton has supplied twenty-two consecutive years of safe drinking water to the public it serves and has been awarded the Secretary's Award for Drinking Water Excellence by the South Dakota Department of Agriculture and Natural Resources. This report is a snapshot of the quality of the water that we provided last year. Included are details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and state standards. We are committed to providing you with information because informed customers are our best allies.

Water Source
We serve more than 1,380

customers an average of 125,000 gallons of water per day. Our water is surface water that we purchase from another water system. The state has performed an assessment of our source water and they have determined that the relative susceptibility rating for the Groton public water supply system is low.

Additional Information
The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage

treatment plants, septic systems, agricultural livestock operations, and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public

water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC

guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Groton public water supply system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take

to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>.

Detected Contaminants
The attached table lists all the drinking water contaminants that we detected during the 2024 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done January 1 – December 31, 2024. The state requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of the data, though representative of the water quality, is more than one year old.

He was an avid Minnesota Vikings and Twins fan. He and Maralyn held Viking season tickets for many years and never missed a home game regardless of the weather. Later, they followed Northern State Wolves basketball with the same intensity.

Ron had the same passion for his faith as he had for sports. He was always very active in his church in positions of leadership and was ahead of his time pioneering the “streaming” of church services on the local access channel. He and Maralyn were involved in Lutherans For Life, manning the Brown County Fair Booth for many years. He also purchased a trailer and created the Witness of the Crosses mobile display that is still in use today. Following his son’s injury, Ron became a strong advocate for victims of traumatic brain injuries. He started the Aberdeen Area Brain Injury Support Group that later influenced others around the state and even extended outside of South Dakota. He served as the chairman of the South Dakota Freedom to Work Leadership Council which advised and influenced state legislators and policy makers regarding those affected by brain and other injuries.

Celebrating his life is his wife, Maralyn of Aberdeen, his children, Kyle (Cindy) Hoops of Cedarburg, WI, Karleen (Scott) James of West Chester, IA, Kolin (Abby) Hoops of Denver, CO, Kelly (Neile) Hoops of Sturgis, eight grandchildren: Kayla (Aaron) Waller, Tyler (Gabby) Hoops, Blake James, Ashlee James, Becca Dhlwayo, Gwen Hoops, Owen Hoops, Liam Hoops and five great-grandchildren. DANR Announces Nearly \$140 Million for Statewide Environmental Projects

Groton receives \$6.5 million

PIERRE, S.D. – Today, the South Dakota Department of Agriculture and Natural Resources (DANR) announced that the Board of Water and Natural Resources has approved \$139,791,400 in loans and grants for drinking water, wastewater, and solid waste projects in South Dakota.

The \$139,791,400 total consists of \$121,686,200 in low-interest loans and \$18,105,200 in grants to be administered by the Department of Agriculture and Natural Resources.

“Safe and reliable water, wastewater, and solid waste infrastructure is essential for protecting our natural resources and building stronger communities for future generations, said DANR Secretary Hunter Roberts. “I want to thank the Board of Water and Natural Resources for approving the funding recommendations.”

Funds were awarded from DANR’s Drinking Water State Revolving Fund Program, Clean Water State Revolving Fund Program, Consolidated Water Facilities Construction Program, Water Environment Fund, and Solid Waste Management Program. Here are some of the recipients:

Aberdeen received a \$30,000,000 Clean Water State Revolving Fund loan to replace equipment and implement improvements to the treatment process, increasing the capacity of its wastewater treatment facility. The project previously received funding in April 2022. The loan terms are 3.75% for 30 years.

Brown County received a \$675,600 Solid Waste Management grant to help construct a fifth cell at the landfill.

Brown County also received a \$213,700 Solid Waste Management grant to assist in purchasing a new landfill compactor.

Columbia received a \$3,714,000 Clean Water State Revolving Fund loan with \$2,863,000 in principal forgiveness to replace sewer mains and construct a new wastewater treatment lagoon system. A lift station and a force main will also be built to reroute sewage to the new system. The loan terms are 3.75% for 30 years.

Groton received a \$4,587,000 Clean Water State Revolving Fund loan and a \$2,000,000 Consolidated Water Facilities Construction Program grant to replace a lift station, purchase a generator, construct a new force main, and add a new cell to the wastewater pond system. The loan terms are 3.75% for 30 years.

Hecla received a \$2,500,000 Clean Water State Revolving Fund loan with \$2,000,000 in principal forgiveness to reconstruct a portion of the sewer collection system. This funding is for the second of three phases. The loan terms are 3.75% for 30 years.

Water Investment in Northern South Dakota (WINS) received a \$2,000,000 Water Environmental Fund Appropriation grant to provide up to 42.1 million gallons per day of treated drinking water to the northeast South Dakota region. The project is a collaboration between the city of Aberdeen, BDM Rural Water System, and WEB Water Development Association and consists of 148 miles of pipeline and associated water treatment and storage infrastructure.

WEB Water Development Association received a \$713,000 Consolidated Water Facilities Construction Program grant to replace Pleasant Valley’s existing water system with new water lines and install new water meters, pits and valves. WEB Water will then serve Pleasant Valley as individual members.

Webster received a \$1,129,000 Clean Water State Revolving Fund loan to reline the sanitary sewer system in their Industrial Park. The loan terms are 3.75% for 30 years.

One of the main factors that brings China's EV success is robust government support. For years, China has offered substantial subsidies, tax incentives and infrastructure investments to enhance EV sales and manufacturing. China also has control over a large part of the world-wide battery supply chain, which provides its car makers an edge regard to cost and access to crucial components. Firms such as BYD, Nio and XPeng have emerged as global leaders, providing EVs that are not only less expensive than Western options, but also equipped with advanced technology. These elements enable China to sell its EVs globally, surpassing American and European car makers in both production scale and cost-effectiveness.

Because of these barriers, some Chinese carmakers are looking at different ways to enter the market. One possible strategy is making EVs in Mexico, whereby they'd benefit from the USMCA trade agreement and potentially avoid some tariffs. Others might partner with Western brands to supply batteries or technology, which would let them compete in a more indirect way. Many American EVs already have Chinese components, so even without full vehicle imports, China still plays a big role in the U.S. industry.

Colon cancer is the second leading cause of cancer-related deaths in men and women. The lifetime risk of

Colonoscopy remains the gold standard for colon cancer screening. While detecting cancer early on is important for survival from any cancer, detecting and removing precancerous polyps during a colonoscopy before they develop into cancer is the main reason regular screenings with colonoscopy have been found to reduce colon cancer rates.

Thankfully, a large majority of patients do not have any complications from colonoscopy. The complication rate depends on age and risk factors and the reason for the procedure. The overall rate is approximately 0.5%. The most serious complication risk, a perforation or tear in the colon, is about 1 in 1,000.

Stool tests have been an easier, cheap, non-invasive method for colon cancer screening for many years. Often these tests look for blood in your stool. The latest, more expensive option, Cologuard, checks for blood and DNA abnormalities, and is the most successful of the stool tests at detecting colon cancer, at 94%. However, it is only about 43% effective at detecting advanced adenomas, those precancerous polyps that are already getting larger and closer to becoming cancer. This limits the test's potential at preventing cancer.

The FDA recently approved a new blood test for colon cancer screening. However, it only detected 83% of colon cancers, and only 13% of precancerous advanced adenomas. With this poor detection rate, out of 100 people with cancer, the blood test would falsely tell 17 people that they did not have cancer, and it would miss most precancerous polyps.

Each method has its own pros and cons, so please talk with your doctor regarding which screening method makes the most sense for you. In the end, “the best colon cancer screening method is the one that gets done.”
