Superintendent Joe Schwan talked about the sticker shock that spectators have seen

Superintendent Joe Schwan talked about the sticker shock that spectators have seen at the price of admission of the region volleyball tournament. The cost increased by \$2 a person from \$7 to adults to \$5 for students. Even at Britton, knowing there would be lots of questions, there was a sign posted on the door stating that the admission price was set by the South Dakota High School Activities Association.

Schwan said it has been 11 years since the price of admission was raised, but the fact that it went up \$2 has raised a lot of eyebrows and raised a lot of questions. Schwan reported that the SDHSAA is setting up a foundation of which the SDHSAA has already contributed \$55,000 towards it and that \$1 from each admission ticket will be added to the foundation. Schwan said no one will really see any benefit until the foundation gets \$1 million, but even more importantly, it is really vague of the purpose of the foundation. About 70 percent of the revenue raised by the SDHSAA comes from post regular season games. The roof has been fixed. "It is done correctly," said Dean Marske of HKG Architects. dealt with. Now the next question that needs to be answered is how much of the \$11,400 repair bill is going to be paid for by the district. "That is something you will need to discuss," Marske said. He said that the amount is not zero because of some additional work that was done, but it's also not the full amount. He suggested that the board talk with their attorney to figure out a plan of action.

Parents will be getting a letter from the school district on the night of parent-teacher conferences. The letter will outline the new Smart Assessment Tests that will be given. The new assessment tests will be taken on-line and will replace the paper and pencil Dakota Step Test.

Miranda Haugen and Samantha Azbel will be working at the middle/high school in special education, Danielle Weisz will be working with Janel Lone and Sabrena Schmidt will be working with Deb Winburn at the elementary school.





Railroad crossing work completed


Now your teeth will not fall out when you cross the railroad tracks on Broadway on the south edge of Groton.

the match, "You can have an exciting volleyball match when you put two good teams together." And last night, Groton Area knocked off top seeded Britton-Hecla to advance to the region championship game on Tuesday.

"I challenged the girls at the beginning of the year," said Coach Aaron Helvig, "that there's one thing missing up on the wall in the Arena. There's no banner for volleyball. Wouldn't be awesome if we could do that. We want to reach our goal and do something that's never been done before in our school history. Volleyball has been in Groton since the late 1980s.'

Groton Area and Britton-Hecla engaged in battle from the very first game. The Braves jumped out to a 2-0 lead but Groton tied the game at three, four and six before taking a 7-6 lead. But then Britton-Hecla went on a rally to score seven straight points to take a 13-7 lead. The Braves later added four more consecutive

points to take a 22-14 lead and went on to win, 25-18.

Groton had the 1-0 lead in the second game, but then dua a hole and got into trouble as Britton-Hecla took a 10-6 lead. Then Britton-Hecla started to lose control by hitting the ball out of bounds, serving into the net and having a violation at the net. Groton closed to within one, 11-10. The Braves called time out. Groton gave Britton-Hecla a point with a hit out of bounds to make it a 12-10 Britton-Hecla lead. Camille Sippel had a kill and Nikki Koehler had three ace serves as Groton took a 14-12 lead.

The Braves tied the game at 14, but then frustration started to set in. Britton-Hecla hit the



Like Assistant Coach Joel Guthmiller said after ball out of bounds three times, served into the net and Koehler had a an ace serve as Groton took a 20-15 lead. Britton called time-out, but Britton hit into the net, hit the ball too many times and couldn't contain a tip over by Camille Sippel as Groton took a 23-16 lead. Britton-Hecla gave Groton a point with a serve into the net and on the final point, Sippel had a slam kill as Groton won, 25-16.

> The third game was nearly identical to the second with Groton getting the 2-0 lead, but then quickly falling behind, 6-2. The Braves upped their lead to six at 15-9. Then trouble set it once again for Britton-Hecla. Sippel had a hard hit that bounced off a player, Josie Doeden followed with a kill in empty floor space, the Braves lost control of the ball and couldn't return a serve as Groton closed to within two, 15-13.

> Groton continued to peck away at the lead. Regan Lewandowski had a nice dig that set Josie Doeden up with a kill and that was followed by a Camille Sippel ace serve as the game was tied at 16. The game was tied at 17 and 19. Doeden slammed the ball between two defenders at the net as Groton hit the 20 mark first. Kylie Hawkins had a kill in the back court. Emily Bremmon had a hard kill over Groton's defenders at the net to make it 21-20. "We did a great job shutting down Bremmon," Helvig said. "Josie (Doeden) has the best reach. (Madeline) Carlson and Brennon reach really high to hit over the block, but they didn't get that many over the block hits.'

> It was still a one-point game at 22-21. Halle Dohman had a block as the ball dropped behind the defenders to give Groton a 23-21 lead. Britton answered with a kill, 23-22. The Braves tied the game at 23 as a tip-over the net dropped in the middle of no defenders. Groton then called time out to regroup.

> Doeden had a hit that went unanswered and the game ended with Doeden getting a block at the net, 25-23.

"Everyone took their turns," Helvig said as Sippel had a some great hits early in the match and Doeden was getting her turn. "Josie (Doeden) they were taking triple blocks at her and she still got kills at them. Our back row played phenomenal. We did a really good job digging up stuff and not giving up a lot of floor in the back when the volleys got going back and forth. Our hitters were aggressive and our back court did their job.'

Britton-Hecla gave Groton its first three points in the fourth game with a hit into the net, hitting the ball too many times and a block that went out of bounds. Britton-Hecla gave Groton three more points with a hit out of bounds, one into the net and a violation. Sadie Rogers got one of Groton's points with a tip over and Kylie Hawkins had an ace serve as Groton took an 8-2 lead.

The Braves closed to within two several times and then made it a one-point game, 13-12. Britton's had no good luck for at one point, Britton-Hecla got a point, but after a conversa-tion among the officials, it was reversed on a net violation so instead of a tied game, Groton took a 14-12 lead. The Braves were frustrated as they were losing control of the game. Courtney Kurtz and Kylie Hawkins each had a tip-over. Britton-Hecla was over-hitting the ball, having net violations and hitting serves into the net as Groton went on to win, 25-19. "We were talking on the way up here that if we Josie Doeden gets a spike at the net.

Sisseton snatches region volleyball title away from Groton

Groton Area dropped three games in the region championship game as Sisseton will advance to the state tournament next weekend in Aberdeen.

"It's tough when you battle that hard and put that much into it and come out on the losing end so close," said Coach Aaron Helvig. "It's so hard. As a coach it's hard. As a player it's even harder. I've been in those situations as an athlete and it's heartbreaking. You put so much into it and you don't come away with a win. Like I said, volleyball is like a rollercoaster and the smaller the ups and downs, the better you are. We had a lot of emotional highs and emotional lows tonight."

Sisseton jumped out to a 5-0 lead in the first game and upped it to 9-2. The Redmen held a five-point lead at 14-9 before Groton started to rally. The Tigers closed to within one, 14-13, and again at 15-14, but the Redmen continued to hold the upper hand and went on to win, 25-18.

Groton quickly jumped out to a 3-0 lead in the second game and held a two to five point lead for most of the game. The game started to get intense towards the end. Regan Lewandowski had an ace serve when Sisseton called time out with Groton leading, 22-18. The crowds on both sides were getting into the match. "Not very often do you have a crowd that gets after it like that," Helvig said. "When you're in a time out huddle and you can't hardly hear yourself talk, it's amazing. Not very many times in the 10 years I've been coaching volleyball, with lots of big tournaments, that you get a crowd like that. This is a fun time. This is something they will remember, either way."

Kylie Hawkins had a solid hit to give Groton a 23-18 lead. Then Groton hit one out of bounds and Sisseton followed with a kill to make it 23-20. Groton then called time out. 

Do you have a medical home?

In Robert Frost's Poem "The Death of the Hired Man," Mary and Warren sit on the back porch steps talking of their old hired man who this night returned to their farm in his last dying days promising to work again. It is then that Warren speaks to the value of having a place to go:

'Home is the place where, when you have to go there, They have to take you in.'

The same goes for having a medical home. As a kid, growing up in rural South Dakota, I knew my doctor, and for our family he would give our immunizations, sew-up our lacerations, treat our sore throats, and help relieve our pain. He would even be there to support us when we were struck with impossible tragedy. His was a place where, when you had to go there, he would take you in, and do his best to help. I didn't realize at the time how extremely valuable access to health care could be.

Years later in an Atlanta hospital, as an intern, I rotated onto the team that had to face vast waiting rooms of patients, some waiting more than twelve hours. I remember one fellow intern who bragged about seeing 45 patients in less than three hours. It is hard to call that "access" when you get less than four minutes with a green intern for a medical problem that was trouble enough to cause you to wait that long.


Still, many people in this country, especially those without insurance, have access to health care only through an extremely expensive emergency room somewhere. There they wait to see a complete stranger who must see them as a liability risk, and thus is encouraged to order every expensive test. However, in the end, the ER doc's hardest and most important job is to find somewhere or someone to take the patient in follow-up.

And what's worse, too often there is no one to take the hand-off, no medical home where the patient can go. Too many are medically homeless. I believe that, in our society, every person should have a medical home, and until then, health care costs will continue to rise, and quality will continue to be inadequate.

So far in rural South Dakota, most of us still do have a medical home, now often a PA/nurse practitioner/doctor team, and we should realize that it is something of extraordinary value.

After all, everyone needs a place that, when

we have to go there, they will take us in.
