

### **Groton boys beat Britton-Hecla**

Kyler Ell made three three-pointers as he scored 22 points to help Groton Area beat Britton-Hecla in boys basketball action Tuesday night in Britton, 63-41.

Groton Area led at the quarterstops at 21-9, 32-17 and 43-30.

Hunter Lerew added 14 points while Lucas Sternhagen had 10, Spencer Knecht six, Chance Strom five, Landon Larson four and Bennett Shabazz added two points.

Sternhagen had five of the team's 14 assists, Lerew had two blocks and Wyatt Larson had one, and Groton had 29 rebounds with Sternhagen having seven. The Tigers had 15 turnovers with eight of them being steals. Groton made 54 percent of its field goals and was three of four from the line off of Britton-Hecla's three team fouls.

Eric Wegleitner led Britton-Hecla with 14 points followed by AJ Andreson with 11, Cully Olesen had eight, Jared Rabenberg five and Logan Kann added three points.

The Braves made 32 percent of their field goals, was four of seven from the line off of Groton Area's 12 team fouls, had three blocks with two by Andreson, eight assists with three by Olsen and 23 re-

bounds with eight by Andreson. The Braves had 15 turnovers with nine of them being steals and Ell having four steals.

Groton Area won the junior varsity game, 47-20. Seric Shabazz led the Tigers with 17 points followed by Adam Herman with 11, Aaron Severson had eight, Bennett Shabazz five and adding two points each were Sean Schuring, Marshall Lane and Turner Webb.

**Today in Weather History** 

1983: Freezing rain coated much of eastern South Dakota with up to a half inch accumulation before it changed over to light snow from the late evening of the 28th to the late evening of the 29th. The combination of ice, light snow, and very strong winds made travel extremely difficult. Numerous accidents and stranded vehicles resulted. Visibilities were near zero at times.1996: Extreme wind chills developed across central, north central, and northeast South Dakota as well as west central Minnesota as cold arctic air moved in behind an area of low pressure. With temperatures falling well below zero and northwest winds increasing to 20 to 35 mph, wind chills were lowered to 40 to 70 below throughout the night of the 28th and into the evening of the 29th. Two to five inches of snow had fallen across the area. The strong northwest winds caused areas of blowing snow significantly reducing visibilities. Big Stone and Traverse counties experienced a blizzard for about six hours on the 29th.

2013: A low pressure system moving slowly across the region produced a moderate to heavy band of snow across much of central and northeastern South Dakota. Snowfall rates were greater than one inch per hour in some locations. Several area schools and businesses were either closed or opened late on the 29th.

1887 – Snowflakes "as large as milk pans" fell across several square miles of Montana. The flakes, which were measured at 15 inches across and 18 inches thick, hold the unofficial size record!

1922 - The "Knickerbocker" storm immobilized the city of Washington D.C. The storm produced 28 inches of snow in 32 hours, and the heavy snow caused the roof of the Knickerbocker movie theatre to collapse killing 96 persons. (David Ludlum)

1963 - The low of -34 degrees at Cynthiana, KY, equalled the state record established just four days earlier at Bonnieville. (The Weather Channel)

1977 – A blizzard struck northern and eastern Iowa on January 27-28 bringing all travel to a halt. Despite only 1 to 2 inches of new snow, winds gusting to as high as 55 mph blocked roads with drifts of 6 feet or deeper and wind chills dropped to 60 to 90 degrees below zero with many frostbite cases reported.


1987 - A storm moving out of the Central Rockies into the Northern Plains Region produced up to a foot of snow in the Colorado Rockies, and wind gusts to 99 mph at Boulder CO. High winds in Colorado caused 5.6 million dollars damage. (National Weather Summary) (Storm Data)

1988 - Barometric pressure readings of 30.55 inches at Miami FL, 30.66 inches at Tampa FL, and 30.72 inches at Apalachicola FL were all-time record high readings for those locations. (National Weather Summary)


1989 - Nome, AK, reported an all-time record low reading of 54 degrees below zero, and the temperature at Fairwell AK dipped to 69 degrees below zero. Deadhorse AK reported a morning low of 49 degrees below zero, and with a wind chill reading of 114 degrees below zero. In the Lower Forty-eight States, a winter storm over Colorado produced up to 15 inches of snow around Denver. (National Weather Summary) (Storm Data)


1990 - Strong and gusty winds prevailed across the northwestern U.S., and heavy snow continued over the mountains of Washington State and Oregon. In Idaho, Mullan received seven inches of snow, and winds gusted to 65 mph southeast of Burley. Heavy rain soaked coastal sections of western Oregon. Rainfall totals of 1.20 inches at Portland and 1.57 inches at Eugene were records for the date. Winds in Oregon gusting to 60 mph downed power lines in Umatilla County knocking out power to more than 13,000 homes, just prior to the kick-off of the "Super Bowl" game. (National Weather Summary) (Storm Data)



**Where To Find Security** 

David had no fear of being honest. He faced life with an openness that allowed him to vent his feelings, state his fears, express his desires, and claim God's promises.

"Keep me safe, O God!" is the way David begins Psalm 16. And then states immediately that he, at that moment, came to Him for refuge: "In you I take refuge." He did not say that he took refuge in God in the past or that he planned on taking refuge in God in the future. Indeed not. Something was threatening him at that very moment and he immediately went to God for help.

Sometimes we wait before we go to God with our needs. We believe that we are capable of handling our fears and failures by ourselves. We often think that we can cover up our mistakes and faults. But there is nothing in us or about us or has come from us that is beyond God's love, mercy and power. He knows who we are, sees us as we are and understands what we are going through and is waiting for our call for help.

The word keep as used in this psalm can also be interpreted to mean watch over – as a shepherd watches over his flock, or as a guard who keeps watch over the prisoners he is charged to control and contain.

David knew the responsibilities of shepherds first-hand. If anything happened to the sheep, the shepherd would be held accountable. He also knew, as a king, that if prisoners escaped, an entire kingdom

could be damaged or destroyed. David knew Who to trust!

**Prayer:** Help us, Father, to place all of our confidence in Your love and power when we face the unknown. In Jesus' Name, Amen.

#### Police now probing reports of students harassed at game

RAPID CITY, S.D. (AP) — Police are now looking into reports of harassment directed at grade-school students from the Pine Ridge Indian Reservation who attended a Rapid City Rush hockey game.

Chaperone Justin Poor Bear says students from the American Horse K-8 school in Allen were subjected to racial slurs and had beer sprayed on them at the Rushmore Plaza Civic Center on Saturday.

Police Lt. Mark Eisenbraun says parents of some of the children called the department, and it has opened an investigation.

Rapid City beer distributor Eagle Sales said earlier that guests in the company's suite at the Civic Center were responsible for the poor behavior, and apologized.

The company, the hockey team and the civic center all are looking into the matter.

### More warm temperature records fall in the Northern Plains

BISMARCK, N.D. (AP) — Warm Pacific air blanketing the Dakotas continues to set records in the two states, with temperatures reaching into the 50s, 60s and even 70s.

National Weather Service reports show that record-high temperatures for the date were set Tuesday in Bismarck, Dickinson and Williston in western North Dakota, and in Rapid City in western South Dakota. It reached 73 degrees at the Rapid City airport.

Rapid City and Bismarck also set record high overnight lows on Tuesday.

Forecasters say the jet stream moved to the north and allowed the warm Pacific air to flow in early this week. A lack of snow cover also is contributing to the warmth.

But colder weather is on the way. Overnight lows this weekend could be as cold as 15 degrees below zero in northeastern North Dakota.

#### \$5M Sanford lab visitor center in Lead set to open by June

LEAD, S.D. (AP) — A \$5 million visitor center for the Sanford Underground Research Facility at Lead (LEED) is on track to open by June.

The Black Hills Pioneer reports (http://bit.ly/1H8fn1g ) work included the installation of 22 steel support piers that go down 100 feet to the bedrock and keep the building stable because it's perched near the edge of the old Open Cut surface mine.

The federally supported lab that's nearly a mile underground in the former Homestake Gold Mine is home to researchers who are studying complex subjects such as nuclear reactions within stars. They're also interested in dark matter, an elusive substance that scientists believe makes up about one-fourth of the universe.

The 8,000 square-foot visitor center will showcase Lead's history and offer educational programs about the lab's science projects.

#### Panel to mull reporting changes for sex offenders' vehicles

PIERRE, S.D. (AP) — A state legislative panel is set to take up a measure that would require registered sex offenders to tell to police within three days if they change vehicles.

The House Judiciary Committee on Wednesday is expected to take up a proposal that would add

getting a new vehicle to other reporting requirements for offenders, such as changing residences or getting a new job.

The bill's main sponsor is Republican Rep. Dan Kaiser of Aberdeen. He says that current law requires alerting police within six months.

Kaiser, a police officer, says that the measure will help law enforcement better scrutinize vehicles parked outside of day cares and schools. The proposal would also help police if the vehicle was used as a mobile crime scene.

#### Panel to debate studying effects of economic collapse on SD

PIERRE, S.D. (AP) — A state legislative panel is scheduled to take up a measure to study how a serious and long-term national economic collapse would affect South Dakota.

The House State Affairs Committee on Wednesday is expected to debate a measure to create the Economic Contingencies Work Group to prepare for such a crisis.

The bill's main sponsor is Republican Rep. Steve Hickey. He says that significant uncertainty in the national and global economy means the state should start contingency planning to respond to a financial disaster.

The task force would study scenarios such as: A 20 percent reduction in federal aid to the state, the collapse of the dollar and a serious disruption in food and fuel.

Hickey says it's important to ask tough questions because "this is a house of cards."

### Bicycle safety legislation again stalls in House committee JAMES NORD, Associated Press

PIERRE, S.D. (AP) — State lawmakers want to make bicycling safer in South Dakota, but they're having trouble figuring out how exactly to do it.

The House Transportation Committee on Tuesday for the second time was unable to reach a consensus over a measure intended to boost safety for cyclists when vehicles pass them on the road. The state Department of Transportation proposed the legislation, which would require a vehicle to stay 3 feet away from cyclists while passing them.

But so far lawmakers haven't been able to come up with an agreement over how large of a buffer should apply or whether country and city roads should be treated differently.

Committee Chairman Mike Verchio said bicycle safety is important, but he didn't imagine the measure would draw so much debate.

"It sounded so simple when it first came up," he said, adding after the hearing: "It's a big deal. Safety's a big deal, and I just want to make sure we've got it right."

Verchio wants to differentiate between city streets and rural highways, where he thinks drivers should have to change lanes to go around a cyclist.

There are 25 states, plus the District of Columbia, with a 3-foot cushion law, according to the National Conference of State Legislatures.

"We've had some accidents this year, especially in our town, and bike safety is an area where there's

some interest to pass some bills," Rep. Steve Hickey, R-Sioux Falls, said after the hearing.

From 2010 to 2013 in South Dakota, 390 cyclists were injured and three died in collisions with vehicles. Kasey Abbott, president of RASDAK, a roughly 500-mile bike tour across the state, said he would be happy with the 3-foot buffer between passing cars and cyclists. It's when cars blow past only a foot away, he said, that he has been forced into the ditch.

Abbott said his first concern is getting the roughly 150 riders expected to take part in the tour in June safely across the state while having fun in the process. So far, registrants hail from states ranging from Connecticut to Alaska.

"I would love to be able to tell them, 'Hey, we just passed this 3-foot rule, and we're stressing safety in South Dakota," Abbott said.

The committee on Tuesday appointed a sub-panel, which is expected to meet on Wednesday to begin negotiating a solution.

### Mid-winter warmth blanketing the Dakotas, breaking records BLAKE NICHOLSON, Associated Press

BISMARCK, N.D. (AP) — As a blizzard slams the Northeast, mid-winter warmth is breaking records in the northern Plains.

Record-high temperatures in the 50s and 60s were set in parts of the region Monday, and Tuesday temperatures climbed higher, reaching 73 degrees in Rapid City in western South Dakota, and 62 degrees in Dickinson in western North Dakota, according to National Weather Service reports.

On Monday, Rapid City and Dickinson, along with the city of Williston in western North Dakota, broke warmth records, with highs ranging from 50-68 degrees, according to the weather service. Dickinson's previous record of 49 had stood for 84 years.

Residents may have the tumultuous weather to the east to thank for the unseasonable reprieve.

"Cold air from Canada is actually dipping down into the Northeast, and we're getting mild air out of the Pacific," said Todd Hamilton, a weather service meteorologist in Bismarck.

Lacking snow cover in the western and central Dakotas also is contributing to the warmth, Hamilton said. The eastern parts of the states have more snow, and Tuesday's temperatures there were expected to be as much as 30 degrees cooler — but still warm for this time of year.

The northern South Dakota city of Aberdeen — which saw a nearly 50-degree high Monday — was forced to shut down its outdoor skating rinks.

"We've closed them for the next few days while we're getting through this crazy weather," Recreation Superintendent Gene Morsching said. "It's just not worth it to keep them open. The ice deteriorates."

The mild weather wasn't expected to last long with a cold front forecast for Wednesday bringing a chance of light snow to the region. Even colder weather is expected by the weekend, with some overnight lows dropping back below zero.

### House passes bill allowing state to respond to more diseases KEVIN BURBACH, Associated Press

SIOUX FALLS, S.D. (AP) — South Dakota could more easily respond to deadly disease outbreaks under a measure passed Tuesday in the state House of Representatives.

The bill, brought by the state Department of Health, would modernize the state's authority to respond to serious communicable diseases. Despite passing the House 41-27 following an amendment that narrowed its scope, the bill faced opposition from lawmakers concerned that it gave the state too much

authority.

Health officials said the state's laws are antiquated and need to be updated to protect South Dakotans from modern diseases that are easily spread, like the Ebola virus.

The proposal originally gave the state the authority to monitor, quarantine or isolate people suspected or confirmed of having a top-tier communicable — or Category 1 — disease. It was amended Tuesday to cover just five, including Ebola and Tuberculosis, which has been on the books for more than 50 years.

The Health Department said it limited the scope of the bill to alleviate fears of government overreach while still giving the state enough power to protect the public's health.

"True, if someone comes back to this country and has been exposed to Ebola, they may have their personal liberties restricted for a brief period of time until we know they're safe," said Rep. Karen Soli, a Sioux Falls Democrat. "For me, that's a small thing that for the safety of all of us, I don't have any problem at all with this taking place."

Rep. Lynn DiSanto, a Rapid City Republican, followed Soli with an often-cited quote from Benjamin Franklin about liberty and safety. DiSanto said the proposal would infringe upon the freedom of people to make their own decisions about their health.

"Do not let the scare of Ebola lead us into making a hasty decision that has a far-reaching impact," she said. "When the government decides to make mandatory any health concern, they remove the liberty and relationship between a patent and their health care provider."

Under the existing law, it's a misdemeanor for anyone who has Tuberculosis to refuse to accept the diagnosis or treatment of their illness or refuse to comply with Health Department orders. The proposed measure would also make it a misdemeanor for the other four diseases the department is proposing: Ebola, Middle East Respiratory Syndrome (MURS), Severe Acute Respiratory Syndrome (SARS) and Smallpox.

The bill passed out of the House on Tuesday would also create a process by which the department could work with the court system to obtain judicial orders for those who refuse comply.

The measure originally had an emergency clause, which means it would take when the governor signs it, but that was removed in an amendment Tuesday.

The bill will now move onto a Senate committee to be heard.

### Utility to add more electricity generation in Montana

BILLINGS, Mont. (AP) — Montana-Dakota Utilities says it plans to install more electricity generation to its power plant in Sidney, Montana, to keep up with growing customer demands.

The 19-megawatt addition would be powered by natural gas and located within the company's Lewis and Clark coal plant.

It would be used to provide power to customers during times of peak demand and could reach full power within 10 minutes.

MDU spokesman Mark Hanson says construction costs are estimated at \$40 million.

MDU provides electricity to 137,000 customers in Montana, Wyoming and the Dakotas. Hanson says the number of customers has been increasing by 4 percent to 6 percent annually, driven in part by the oil boom in the Bakken region of Montana and North Dakota.

#### Kimball man pleads insanity to standoff and shooting charges

CHAMBERLAIN, S.D. (AP) — A Kimball man accused of shooting a Highway Patrol trooper during a daylong standoff pleaded not guilty and not guilty by reason of insanity.

Donald London is charged with two counts of attempted murder and three counts of aggravated assault against a law enforcement officer.

The 42-year-old and his father, 66-year-old Michael London, were arraigned Tuesday in Chamberlain. Prosecutors say Donald London fired his rifle and struck Highway Patrol Sgt. John Koenig when troopers surrounded his house after he threatened to kill the Chamberlain police chief.

Koenig is out of the hospital and was in court Tuesday.

Attorney General Marty Jackley says more than 100 rounds were fired from the house during the lengthy standoff.

Michael London pleaded not guilty to charges of aiding and abetting the crime.

#### Feds warn of thin ice on North Dakota, South Dakota water

BISMARCK, N.D. (AP) — Federal authorities are encouraging people in North Dakota and South Dakota to watch out for quickly changing ice conditions on all reservoirs in the states.

The U.S. Bureau of Reclamation says winter snowpack that's melting due to warmer than normal temperatures has increased water inflows enough to cause rapid shifts in ice conditions.

Dakotas Area Office manager David Rosenkrance says the changing water elevations and increased runoff create thin ice that makes rivers and lakes unsafe. He says the elevations change the ice conditions with no warning.

### **Human trafficking bill introduced by Noem passes House**

WASHINGTON (AP) — The U.S. House of Representatives has passed legislation introduced by U.S. Rep. Kristi Noem targeting human trafficking.

Her office says the bipartisan Human Trafficking Prevention, Intervention, and Recovery Act passed Tuesday would give caregivers, state law enforcement officers and others help in preventing trafficking and help create safe places for victims.

The measure also would start a review to look into federal and state trafficking prevention activities in hopes of identifying the best way to stop it.

The legislation introduced by Noem passed the House late last year, but the Senate failed to consider it. The South Dakota Republican reintroduced it at the beginning of this Congress with California Democrat Rep. Doris Matsui.

#### American Indian tribes to discuss legal pot at conference

SEATTLE (AP) — American Indian tribes wrestling with whether to legalize marijuana have scheduled a national conference on the topic next month in Washington state.

Organizer Robert Odawi Porter, a tribal law expert and former president of Seneca Nation in New York, says there's been a lot of discussion among tribes since the Justice Department announced in December that it would allow them to grow and sell marijuana.

A few tribes have expressed interest in the legal pot business. But for many, concerns about substance abuse are paramount. Porter says the conference will explore the legal, business, social and cultural questions facing tribes when it comes to marijuana.

#### Proposed egg farm drawing complaints in Turner County

PARKER, S.D. (AP) — A Sioux Falls-based company hopes to more than double the number of egglaying hens in South Dakota by opening a large chicken operation near Parker.

Sonstegard Foods hopes to put 6 million birds on a farm in Turner County. Supporters say the project could employ as many as 150 people, give farmers a steady source of fertilizer and boost grain prices.

"We take a significant amount of our corn out of state," Keith Alverson, president of South Dakota Corn Growers, told the Argus Leader. "Anything that can keep that grain in our state is a good thing."

Some area residents worry about odor, traffic, noise and other potential problems. The chicken farm would be  $2\frac{1}{2}$  miles from Parker and only half a mile from the city golf course.

"That's too close to too many people," Mark Joffer told KDLT-TV. "You're going to negatively impact too many people."

Some area residents also question the farm itself.

"It isn't true farming as we think of farming in South Dakota," John Chicoine told KDLT. "It's a 6 million chicken factory. It's a concentration camp for chickens."

Sonstegard Foods says it understands the concerns and will work to be a good neighbor.

"We've gotten a lot of feedback," Peter Sonstegard, the company's vice president of sales, told the Argus Leader. "We've gotten some positive feedback. Yes, we've gotten some negative, as well. But we're taking the time to do this right. You don't just jump to do an \$85 million project without doing some legwork."

Opponents are circulating a petition to present to the County Commission, which must permit the project. Sonstegard Foods also must get easements from landowners within half a mile of the proposed facility.

There currently are about 3.8 million chickens at permitted feeding operations in South Dakota, according to the Argus Leader.

### Mother makes emotional appeal to Japanese prime minister to save son as death threat looms

TOKYO (AP) — The mother of a Japanese hostage held by Islamic State group extremists appealed publicly to Japan's leader to save her son Wednesday after his captors purportedly issued what they said was a final death threat.

Junko Ishido, mother of journalist Kenji Goto, read to reporters her plea to Prime Minister Shinzo Abe, which she said she sent after both Abe and the main government spokesmen declined to meet with her because their schedules were full.

"Please save Kenji's life," Ishido said, begging Abe to work with the Jordanian government until the very end to try to save Goto.

"Kenji has only a little time left," she said.

The effort to free Goto and a captured Jordanian pilot, Lt. Mu'ath al-Kaseasbeh, gained urgency with the release of an apparent ultimatum late Tuesday from the Islamic State group.

### 'I had to jump out the window:' New England digs out as the spared 2nd-guess the forecast

BOSTON (AP) — New Englanders savaged by a blizzard packing knee-high snowfall and hurricaneforce winds began digging out as New Yorkers and others spared its full fury questioned whether forecasts were overblown.

The storm buried the Boston area in more than 2 feet of snow and lashed it with howling winds that exceeded 70 mph. It punched a gaping hole in a seawall and swamped a vacant home in Marshfield, Massachusetts, and flipped a 110-foot replica of a Revolutionary War ship in Newport, Rhode Island, snapping its mast and puncturing its hull.

"I had to jump out the window because the door only opens one way," Chuck Beliveau said in the hard-hit central Massachusetts town of Westborough. "I felt like a kid again. When I was a kid, we'd burrow through snow drifts like moles."

But signs of normalcy emerged: Flights were to resume at dawn Wednesday at Logan International Airport, among the nation's busiest air hubs, and Boston's public transit and Amtrak trains to New York and Washington were set to roll again.

Bitter cold threatened to complicate efforts to clear clogged streets and restore power to more than 15,000 customers shivering in the dark, including the entire island of Nantucket. A 78 mph wind gust was reported there, and a 72 mph one on neighboring Martha's Vineyard.

### Strict NYC storm regulations enacted by Gov. Cuomo and Mayor de Blasio could be the new normal

NEW YORK (AP) — They appeared to be scenes from a frozen apocalypse.

Streets across the nation's largest city were empty, the only movement the changing traffic lights signaling to cars that weren't there. The subway system was shuttered, the city's pulse rendered still. Hardy souls who braved the snow were threatened with fines or arrest.

And it could be the new normal.

Though the snowstorm largely missed New York City, Gov. Andrew Cuomo and Mayor Bill de Blasio staunchly defended their unprecedented, stringent restrictions, both saying they believed in landing on the side of caution and suggesting they would take such measures again.

"Would you rather be ahead of the action or behind? Would you rather be prepared or unprepared? Would you rather be safe or unsafe?" de Blasio asked Tuesday at City Hall. "To me it was a no-brainer: we had to take precautions to keep people safe."

### Human smugglers turn to cargo ships for Syrian refugees seeking better lives in Europe

ABOARD THE COAST GUARD CUTTER TYR (AP) — The crew was about to dig into dinner when word of the "ghost ship" came through: a freighter hurtling out of control toward Italy with no crew — and hundreds of Syrians as cargo.

The cattle freighter — its animal pens crammed with families — was on a collision course with the Italian coast, and the refugee who had phoned authorities from on board said the cabin's controls were jammed. The Tyr changed course and set off on a race against time.

The rescue operation by the Icelandic cutter Tyr was one of the most perilous in a string of high-seas dramas that point to a new modus operandi among smugglers who send migrants across the Mediterranean. Gangs buy scrapyard-bound cargo ships over the Internet and pack them with Syrians willing to pay top dollar to flee their ravaged homeland. The ships are then pointed toward Europe and abandoned, the migrants' fate hanging between shipwreck and rescue.

Until recently, most migrants paid several hundred dollars for a trip aboard an old fishing boat, dinghy or speedboat. Hundreds of men, women and children perish every year in those voyages when their unseaworthy vessels capsize in stormy seas.

The war in Syria, which has driven more than 3 million people into flight, has offered a new, lucrative opportunity for smugglers. Comparatively well-off refugees are able to pay higher prices for passage on bigger, safer ships from the far eastern Mediterranean directly to Italy, from where they then cross overland to central and northern European countries.

SAN FRANCISCO (AP) — Apple CEO Tim Cook says consumer demand for new iPhones has been "staggering" and "hard to comprehend." That helped the company report record-smashing earnings for its latest quarter and primed its stock for a rally Wednesday.

But after selling a record 74.5 million iPhones in three months that ended in December, what can Apple do next?

Some analysts worry that Apple depends too much on the iPhone, which contributes two-thirds of

its sizable revenue — leaving the company vulnerable if some other gadget comes along to replace the iPhone in popularity. Cook and Chief Financial Officer Luca Maestri, however, say they're optimistic about other products in Apple's portfolio. Here's some of what they talked about on Tuesday.

### Senate hearings to begin on Loretta Lynch, who would be first black female attorney general

WASHINGTON (AP) — President Barack Obama's attorney general nominee, Loretta Lynch, is facing Senate questioners as she seeks to become the first black woman to hold the nation's top law enforcement job.

In the first Republican-led confirmation session of the Obama administration, Lynch was to appear Wednesday before the Senate Judiciary Committee as it opens two days of hearings on her nomination. Lynch, the U.S. attorney for the Eastern District of New York, would replace Eric Holder, who announced his resignation last fall after leading the Justice Department for six years.

She already has earned praise from several GOP senators for her impressive credentials and accomplishments, and is widely expected to win confirmation. But first she will face tough questions from Republicans who now control the Senate. The hearing gives them an opportunity to press their opposition to Obama administration policies while showcasing their own governing roles as the 2016 presidential election cycle gets underway.

Holder was a lightning rod for conservative criticism and clashed continuously with Republicans, becoming the first sitting attorney general to be held in contempt of Congress. Republicans want to hear Lynch pledge that she'll do things differently.

### Case of 14-year-old Palestinian girl in Israeli prison for hurling rocks at cars stirs anger

BETIN, West Bank (AP) — The fate of a 14-year-old Palestinian girl, tried before an Israeli military court for hurling rocks at passing cars in the West Bank and sentenced to two months in prison, has gripped Palestinians who say her treatment demonstrates Israel's excessive measures against stone-throwing youth.

Malak al-Khatib, arrested last month, is one of only a rare few female Palestinian minors who have ever faced arrest and sentencing by Israeli authorities.

"A 14-year-old girl won't pose any threat to soldiers' lives," said her father, Ali al-Khatib. "They are well equipped and well trained so what kind of threat could she have posed to them?"

The Israeli military said al-Khatib was charged with stone-throwing, attempted stone-throwing and possession of a knife and that under a plea bargain, she was sentenced to two months in prison and a \$1,500 fine.

Having spent four weeks in detention, al-Khatib has another four left weeks left at a central Israeli prison for women.

### Israel fires artillery rounds into Lebanon after anti-tank missile strikes military vehicle

JERUSALEM (AP) — An anti-tank missile hit an Israeli military vehicle near the Israeli-Lebanese border on Wednesday, the Israeli military said. Lebanese security officials said Israel later fired at least 35 artillery shells into Lebanon.

The exchange sent tensions soaring around the volatile boundary. The military did not immediately report any casualties, and said residents of the area have been ordered to remain in their homes.

Communities along the two countries' shared border have been on edge since last week, when an airstrike attributed to Israel on Syria's Golan Heights killed six Hezbollah soldiers and an Iranian general. It was not immediately clear whether Wednesday's incident was retaliation for that airstrike.

The Shiite militant Lebanese group — a top suspect to have been behind the missile — said it had no immediate comment.

Wednesday's attack took place near Mount Dov and Shebaa Farms, a disputed tract of land where the borders of Israel, Lebanon and Syria meet.

### Govt tells immigration agents to identify immigrants who shouldn't be arrested, deported

WASHINGTON (AP) — The Obama administration has ordered immigration agents to ask immigrants they encounter living in the country illegally whether they might qualify under President Barack Obama's plans to avoid deporting them, according to internal training materials obtained by The Associated Press.

Agents also have been told to review government files to identify any jailed immigrants they might be able to release under the program.

The directives from the Homeland Security Department mark an unusual change for U.S. immigration enforcement, placing the obligation on the government for identifying immigrants who might qualify for lenient treatment. Previously, it was the responsibility of immigrants or their lawyers to assert that they might qualify under rules that could keep them out of jail and inside the United States.

It's akin to the Internal Revenue Service calling taxpayers to recommend they should have used certain exemptions or deductions.

The training materials apply to agents for Customs and Border Protection and Immigration and Customs Enforcement. They instruct agents "to immediately begin identifying persons in their custody, as well as newly encountered persons" who may be eligible for protection from deportation.

### If court kills health care subsidies, most in poll want Congress to restore financial aid

WASHINGTON (AP) — More than 6 in 10 Americans would want Congress to restore federal financial assistance for millions buying health care coverage under President Barack Obama's health care law if the Supreme Court invalidates some of those government subsidies, a poll said Wednesday.

The finding by the nonpartisan Kaiser Family Foundation suggests that a complicated political landscape might await Republicans, who want to repeal and replace the law, should the court annul a crucial part of it later this year.

The court will hear arguments in March in a case that will decide whether Obama's 2010 law allows

federal subsidies only in states that have established their own health insurance marketplaces, and not in states whose markets are run by Washington's HealthCare.gov. The federal government runs the marketplace in 37 states.

The court's decision is expected in June.

Should the court strike down the subsidies, Obama and Congress would have to decide what to do. Administration officials have sidestepped questions about their next move. Congressional leaders have made no decisions, but groups of top lawmakers in both the House and Senate have started considering options.

On Jan. 28, 1915, the United States Coast Guard was created as President Woodrow Wilson signed a bill merging the Life-Saving Service and Revenue Cutter Service. Frye, en route to England with a cargo of wheat, became the first U.S. ship to be sunk during World War I by a German cruiser, the SS Prinz Eitel Friedrich, even though the United States was not at war.

### DOCUMENTS NEEDED TO OBTAIN A SOUTH DAKOTA DRIVER LICENSE OR ID CARD (photo copies cannot be accepted)

Federal requirements have changed the documents required to obtain or renew your South Dakota driver license or identification card. We want to make the process as quick and easy as possible for you. Look over the documents on the list below, and if you have any questions at all, anything you don't understand or any documents you aren't sure you can find, please contact the Driver Licensing Program. You may email DPSLicensingInfo@state.sd.us (please include your first and last name) or call toll-free at 1-800-952-3696 or directly at 605-773-6883.

If you think you will have difficulty obtaining any of the documents please contact us. We may be able to arrange for an extension or a temporary permit while you gather the documents needed to obtain your federally compliant South Dakota driver license or identification card. If you find that you simply

can't produce one of the required documents, we can work with you in those situations. Again, please use the contact information for the Driver Licensing Program if you have any questions or concerns.

The need to show the additional documents is a one-time requirement. That means once you have your federally compliant driver license or identification card in hand, you will only need that card and two documents to show your current address the next time you renew your driver license or identification card. If your driver license or identification card has a gold star in the upper right corner, then it is federally compliant.

Our staff is committed to providing the best service possible, so don't hesitate to contact us by telephone or email. We will help you in any way we can.

Federal regulations require anyone applying for a new, renewal, or duplicate driver license or identification card to provide the documents listed below and on page 2 (photo copies are not acceptable):

I. You will need one Identity Document. NOTE: If your name is different than the name on your identity document, you will need to bring additional proof of your legal name. Acceptable documents for proof of a legal name change are a certified marriage certificate (issued by a state vital records agency), a certified adoption document, or a certified court order authorizing a name change (such as a divorce decree). If you have had multiple marriages, you will need to bring similar documents providing legal proof of each name change (presenting a valid passport with your current name eliminates this requirement).

An Identity Document to prove identity, date of birth, and lawful status is considered to be one of the following:

- ◆ Certified U.S. birth certificate issued by state or county (hospital birth certificates are not acceptable)
  - ◆ Valid unexpired U.S. passport
  - ◆ Certificate of Naturalization
  - ◆ Certificate of Citizenship

Non-Citizens may bring:

- Valid unexpired permanent resident card
- Valid unexpired employment authorization document
- ◆ Foreign passport with valid unexpired U.S. Visa with I-94

**South Dakota birth and marriage certificate information** is available on the state of South Dakota web site at http://www.doh.sd.gov/vitalrecords/order.aspx and through your local County Register of Deeds office. Marriage certificates before 1950 may not be available for same day issuance. - II. You will need <u>one</u> document to prove Social Security number. Only the documents listed below can serve as proof of Social Security number (the document must include your name and full social security number):

  - ◆ Pay stub

III. You will need <u>two</u> documents to prove your residential address. A parent's proof of address is acceptable for a minor child. Proof of address documents may **not be more than one year old**. Please bring two of the documents listed below (each must contain your current physical address):

- Utility bill
- ◆ Pay stub or earnings statement
- ◆ Rent receipt
- ◆ Phone bill
- ◆ Transcript or report card from an accredited school
- ◆ Bank statement
- Mortgage document
- ◆ Tax document
- Homeowners/renter's insurance policy
- Other items with your address can be reviewed by Driver Licensing personnel
- ◆ If you are unable to provide proof of residency, please call 1-800-952-3696 or 605-773-6883 for exceptions.
  - ◆ Post Office Box addresses are acceptable in areas not assigned a street or 911 address

#### **Address Exceptions:**

<u>Minors</u> - If a minor does not have two documents proving residency, the parent may provide two forms for them.

<u>Living with someone else</u> - An individual residing with another person may have the other person sign a "Consent for Use of South Dakota Address" form and present two residency documents belonging to the person with whom they reside. The <u>Consent for Use of Address</u> form may be obtained at the exam station or printed off our website.

<u>Living within an organization or at a facility</u> - Applicants may provide a letter from the organization or facility (on their letterhead) stating the individual resides there.

<u>People who travel full-time</u> - If you are using a mail forwarding address, you must complete the Residency Affidavit. You will also need to provide one document no more than one year old proving your temporary South Dakota address (campground or RV park receipt) and one document no more than one year old proving your personal mailbox (PMB) service address (receipt from the PMB business or a piece of mail with your PMB address on it). If you have friends or family in South Dakota and plan to use their address, you can complete and follow the instructions on the Consent for Use of Address form. <u>Military and Military Dependents</u> - Applicants can use an out-of-state address on their license and provide two documents proving residency showing the out-of-state address.

Before your license or ID card is issued, our examiners will review your documents to make sure they comply with the federal requirements. We will work with you to resolve any problems with your documents and to identify any additional documents or other information that may be necessary to complete the process. The additional requirements are designed to establish a more secure driver license, which will address our shared concern about national security, identity theft and highway safety.

#### **Veterans**

Veterans who have been honorably discharged from the military have the option of adding the word "Veteran" to the front of their South Dakota driver license or identification card. In addition to the documents listed above, they will need to present:

- ◆ DD-214 form which shows their honorable discharge status from active duty or
- ◆ Present a certificate signed by a county or tribal veteran's service officer verifying their status.
- ◆ DD Form 2 (Retired)
- ◆ DD Form 2A (Reserve Retired)

Note to CDL holders: If you are required to carry a medical examiners certificate (aka DOT medical card) you must show a valid card at the driver exam station.
