## State wrestling this weekend

PIERRE – The 56th Annual South Dakota State High School Wrestling Championship Tournaments will take place this Friday & Saturday, featuring the Class 'A' Tournament in Sioux Falls and the Class 'B' event in Rapid City. A total of 16 returning individual state champions will be participating, as well as Defending Team Champions Parkston and Aberdeen Central. Both tournaments can be viewed with live statistics and results via South Dakota Public Broadcasting's website: sports.sdpb.org.

The Class 'B' field features eight returning Individual Champions, including one young man who will be gunning for his fourth straight individual title: 138-pound Luke Loudenberg of Howard (34-1, titles at 13-2 pounds in 2014, 120-pounds in 2013, 106-pounds in 2012). In addition, four young men have an opportunity to cap an undefeated season: Sam Ireland of Bennett County (38-0, 160 pounds), Kurt Braun of Burke/Gregory (7-0, 138 pounds), and a pair of Bon Homme/Scotland competitors in Duncan Stoebner (36-0, 120 pounds) and Dan Stibral (28-0, 285 pounds).

On the Class 'A' side, ten individual state champions return, highlighted by 160-pound Regan Bye of Vermillion. Bye is a perfect 47-0 on the 2014-15 campaign, and is seeking his third individual state title after reaching the top of the podium in 2013 & 2014 at the 145-pound weight class. Four other individuals will look to cap an undefeated season on the Class A side as well, including Brett Bye of Vermillion (39-0, 170 pounds), John Frisco of Aberdeen Central (38-0, 182 pounds), and a pair of Rapid City Central Cobblers: Hayden Hansen (41-0, 145 pounds) and Martin Mueller (36-0, 195 pounds).

The chase for the team title in Class 'B' is one to knock-off two-time defending champion Parkston. Beresford, Bon Homme/Scotland and Parkston are the lone three schools to qualify ten or more wrestlers for the meet and figure to lead the way to the title chase with Canton's eight wrestlers also in strong contention. Aberdeen Central is the lone team in either class to qualify all fourteen wrestlers to the State Finals and figures to lead the Class 'A' title chase, followed by Pierre, Huron and SF Roosevelt who each qualified 13 participants.

## South Dakota Black Hills Fisheries Management Plans Available for Review

PIERRE, S.D. – The South Dakota Game, Fish and Parks' (GFP) Division of Wildlife has drafted two five-year Black Hills fisheries management plans, one for streams and the other for reservoirs, and is currently seeking comments from the public.

"The current Black Hills' streams plan is over 20 years old as is the last comprehensive angler opinion survey on fisheries management in the Black Hills," stated John Lott, GFP chief of aquatic resources. "Several outreach techniques were conducted to develop these plans; including angler focus groups, a comprehensive angler opinion survey and open house events. Public review and comment on these plans is encouraged and is essential as part of the planning process."

An open house event will take place Monday, March 2, 2015, from 6 p.m. – 9 p.m. MST at the Outdoor Campus in Rapid City to discuss each of the plans and answer attendee questions.

Final versions of each of these plans are scheduled for adoption by the GFP Commission at the April 1-2, 2015, meeting in Brookings.

#### **Gasoline Prices Rising by Leaps and Bounds** NEWS EDITORS: This is AAA South Dakota's weekly Tuesday press release detailing city-by-city regu-

AAA South Dakota, Feb. 24, 2015 – Motorists in 96 percent of the states are paying more today for gasoline than they did a week ago. Only in Kentucky and Illinois have retail pump prices declined.

"South Dakota's price average for self-serve regular jumped two cents overnight," said Marilyn Buskohl, spokeswoman for AAA South Dakota. "Rapid City's average gas price has risen ten cents over the last week and Sioux Falls has continued to inch up daily."

"Curiously, while retailers were busy bumping up gas prices, crude oil was falling," said Buskohl. "West Texas Intermediate fell \$1.36 yesterday to close at \$49.45 per barrel, its lowest close since Feb. 11."

Both South Dakota's and the nation's average price for regular gasoline have increased for 29 consecutive days, the longest streak of rising prices since last spring. Today's national average is \$2.31 per gallon, 27 cents more than it was one month ago but still \$1.11 less than on Feb. 24, 2014, according to FuelGaugeReport.AAA.com.

"Ample supplies of fuel stateside are expected to keep a ceiling on prices, though there is a good chance that prices will continue to rise this spring," said Buskohl. "Scheduled refinery maintenance is limiting production, plus unexpected problems at isolated refineries have impacted supply."

Last week an explosion at the ExxonMobil refinery in Torrance helped push up prices in California, while bitterly cold weather in the Northeast and Midwest led to a number of refinery problems in those areas.

Global crude oil prices remain volatile, said AAA. Despite U.S. production companies reassessing plans for exploration and production amid shrinking profit margins, domestic crude oil inventories climbed to record levels and output rose to its highest level since 1973, according to a Department of Energy report released last week.

1987: Six to thirty inches of snow fell on this date in 1987 across much of western and central South Dakota. Three to six inches of snow fell in the northeast part of South Dakota. Some of the largest snowfall amounts reported were 30 inches at Phillip, 26 inches at Murdo and Timber Lake, with 15 inches at Rapid City. Numerous accidents occurred in the western and central sections of the state. Many roads were closed including interstate 90 for most of the 27th. Slippery roads were a major factor in the vehicle injuries of three women on Highway 12, six and one-half miles east of Ipswich in the late afternoon of the 27th. The storm began on the 24th and lasted into the 28th.

2000: Unusual February severe thunderstorms produced nickel to quarter size hail in Lyman and Hand counties on this date in 2000.

1922 - The temperature at Los Angeles, CA, soared to 92 degrees to establish a record for the month of February. (David Ludlum)

1977 - Dust reduced visibilities from eastern Virginia through the southeastern states to Florida between the 24th and the 28th. The dust originated in the western Great Plains on the 22nd and 23rd, with wind gusts above 100 mph reported at Guadalupe Pass TX, at White Sands NM, in Sherman County KS, and in eastern Colorado. (The Weather Channel)

1987 - Low pressure in Nevada produced snow from the southwestern U.S. to the Dakotas. Snowfall totals in Arizona ranged up to 82 inches at Alpine. Flagstaff AZ reported 23 inches of snow in 24 hours. Other heavier snowfall totals included 20 inches at Daggett NV, 24 inches at Brian Head UT, 24 inches at Red Lodge MT, and 26 inches at Angel Fire NM. Snow at Los Alamos NM pushed their snowfall total for the winter past their previous record of 123.5 inches. (The National Weather Summary) (Storm Data)

1988 - Overnight snow squalls in the Lower Great Lakes Region buried Pulaski NY under 17 inches of snow. Sunny and mild weather prevailed across the rest of the nation. Havre MT reported a record high of 66 degrees. (The National Weather Summary) (Storm Data)

1989 - Thirteen cities in Florida reported record low temperatures for the date, including Jacksonville with a reading of 24 degrees. Severe cold in Florida claimed three lives, and resulted in 250 to 300 million dollars crop damage. Unseasonably warm weather prevailed in the central U.S. Dodge City KS reported record high of 80 degrees. (The National Weather Summary) (Storm Data)

1990 - Snow spread across the northeastern U.S. Massachusetts was blanketed with 8 to 15 inches of snow, 5 to 10 inches was reported in Rhode Island, and totals in Connecticut ranged up to 10.5 inches at New Canaan. In central New York State, snow and high winds resulted in a number of chain-reaction multiple accidents, and a total of 108 persons were injured. Snow and high winds created white-out conditions along Interstate 87 in Saratoga County NY. Subzero cold was reported from Minnesota through Michigan to northern New England. Duluth MN reported a record low of 26 degrees below zero. (The National Weather Summary) (Storm Data)

Duluth MN reported a record low of 26 degrees below zero. (The National Weather Summary) (Storm Data) 2009 - Two Alaskan communities set their all-time records for highest windspeed. St. Paul registers a wind of 91 mph, and on St George Island the wind reaches 94 mph.

2010 – A strong Nor'Easter spread significant snow and windy conditions across the Middle Atlantic region from Thursday February 25th into Friday February 26th. An area of low pressure developed off the Carolina coast late Wednesday night February 24th and then strengthened as it tracked northward to near Long Island, New York by Thursday evening. As low pressure aloft deepened over the Mid-Atlantic coast Thursday night into Friday, the surface low retrograded and moved westward into northern New Jersey and southern New York. By Saturday February 27th, the low pushed into southern New England and gradually weakened over the weekend. Strong wind gusts were measured throughout the Middle Atlantic region as a result of this coastal storm. Some of the highest wind gusts recorded include: 62 mph measured at Cape May, New Jersey; 52 mph at the Atlantic City Marina; 51 mph at the Mount Pocono Airport and at Lewes, Delaware; and 50 mph at Dover Air Force Base. Wind gusts of 40 mph or greater were also recorded at Philadelphia, Wilmington, and Allentown. Considerable blowing and drifting snow resulted, especially from the Poconos eastward into northern New Jersey. Snow drifts as high as 3 to 5 feet were seen across portions of Warren and Sussex counties in New Jersey. Total accumulations of 20 inches or more were recorded from Morris and Sussex counties in New Jersey westward into Monroe county Pennsylvania. A band of 12 to 18 inches of snow accumulation was measured from Warren and Morris counties in New Jersey westward to Lehigh county Pennsylvania. In addition to snow that accumulated during the daytime on Thursday, many locations across the region experienced a heavier burst of snow with gusty winds Thursday night into early Friday thanks to additional moisture that wrapped around the low pressure system. Some areas saw snowfall rates of 1 to 2 inches per hour, especially from northern New Jersey and into the Poconos. Central Park ended the month with a total of 36.9 inches of snow, making this the snowiest month since records began in 1869.





Light snow persists through early afternoon. Then, Dangerously Cold Wind Chills tonight into Thursday morning.



Light snow will persist through the afternoon. 1 to 2 inches of additional snowfall is possible for parts of northeast South Dakota and west central Minnesota. Lesser amounts are expected elsewhere. Northwest winds will increase to 15 to 20 mph with gusts up to 30 mph this afternoon. Temperatures this afternoon will be steady or slowly falling, plummeting to the single digits below to teens below zero by early Thursday morning. Even more significant will be the wind chill temperatures, which will drop into the twenty below to thirty below zero range by Thursday morning. Cold air will persist through the workweek, but winds should be weaker.

## **SEEKING THE RIGHT "STUFF"**

Years ago while I was a graduate student studying human behavior it was the "rule" of the day to take an endless number of pencil and paper tests. The object, so often stated, was to "provide an understanding of who we were and to bring self-enlightenment and understanding." Some were insightful, some worthless and some actually, if I might say it with respect, really stupid.

Proverbs 18:15 has some great advice for students of all ages and disciplines: "The heart of the discerning acquires knowledge, the ears of the wise seek it out." The first step of a wise person is to understand that he is not wise. How very interesting. Many think their professors possess knowledge and wisdom and sitting in their classes and listening to their lectures will impart the information they need and elevate them intellectually. Others who believe they are learned persons seek to prove their knowledge by having someone or some source validate it. Some think that true knowledge can be discovered apart from God.

The truly wise person is one who is willing to admit that getting knowledge and wisdom is a life long journey that begins and ends with God. Proverbs reminds us over and over again to "let the wise listen and add to their knowledge and let the discerning get knowledge."

## Proposed \$25 million solar farm near Sioux Falls shot down

SIOUX FALLS, S.D. (AP) — Sioux Falls and Minnehaha County officials have decided against allowing construction of a solar farm on the outskirts of the city.

Minnesota-based Geronimo Energy proposed the \$25 million Cherry Creek solar farm, saying it would generate enough power for about 2,000 homes. But some neighbors of the site opposed the idea, saying they worried about a decrease in property values and problems with glare, among other things. Sioux Falls City Council members on Tuesday night voted 6-2 to deny a permit, and a vote by county

commissioners ended in a 2-2 tie.

Geronimo Energy officials declined comment to the Argus Leader.

## Arctic front brings snow, wind and cold to the Dakotas

BISMARCK, N.D. (AP) — The National Weather Service is cautioning residents of the Dakotas about heavy snow, wind and bitter cold as an arctic front moves through the region.

The agency has issued winter weather advisories for snow in the northern Black Hills of South Dakota and much of the eastern part of that state. Forecasters say about half a foot of snow could fall in some areas by the end of Wednesday, and gusty winds will blow it around.

North Dakota is getting lesser amounts of snow, but bitter cold is following on the heels of the precipitation. The weather service says wind chills overnight into Thursday morning will plunge into the minus 30s in all of western and central North Dakota. Forecasters say frostbite and hypothermia can occur within minutes under such conditions.

## ND man pleads guilty to habitual domestic offender charge

BISMARCK, N.D. (AP) — A man with a history of domestic abuse on the Standing Rock Indian Reservation has pleaded guilty to assault.

Samuel Silk Jr. faces five years in prison on a federal charge of domestic assault by a habitual offender. Authorities say Silk has two prior convictions in tribal court.

Silk's lawyers argued earlier that the habitual offender law should not apply because one conviction occurred after the date of the charge referenced in the federal complaint. That motion was withdrawn so the two sides could continue with plea negotiations.

A federal public defender could not be reached for comment.

A sentencing hearing has not been set.

### SD chapters plan variety of activities for National FFA Week

SIOUX FALLS, S.D. (AP) — Several FFÁ chapters around South Dakota have activities planned this week as part of National FFA Week.

#### SD seeks comments for Black Hills fisheries management plans

PIERRE, S.D. (AP) — South Dakota wildlife officials are seeking comments from the public on two proposed management plans for fisheries in the Black Hills.

Officials with the state's Game, Fish and Parks Department have drafted two five-year plans. One plan is for streams and the other for reservoirs.

John Lott is the department's chief of aquatic resources. Lott says the current streams plan in the Black Hills is more than 20 years old. He adds that public input is "essential" in the planning process.

Officials have scheduled an open house for Monday at the department's Outdoor Campus in Rapid City to discuss each plan and answer questions from the public.

The Game, Fish and Parks Commission is expected to take final action on the plans in early April.

#### House committee set to take up youth minimum wage measure

PIERRE, S.D. (AP) — A state House committee is expected to take up a proposal to exempt youth from the minimum wage hike to \$8.50 that voters approved in November.

The House Commerce and Energy Committee on Wednesday is scheduled to review the plan, which would carve out a \$7.50 youth minimum wage.

Republican Sen. David Novstrup has said the evidence he's seen shows that states with a higher minimum wage also have higher youth unemployment.

His proposal would affect people under age 18, and the \$7.50 youth wage wouldn't be subject to future cost of living increases.

Novstrup has said that the discussion around the ballot proposal that passed in November wasn't around younger workers.

He has said his proposal is a small change to the law.

#### New enrollment period for artists hoping to teach in schools

PIERRE, S.D. (AP) — The South Dakota Arts Council says it has created a new enrollment period for artists interested in working at schools and with nonprofits.

The Council says artists wanting to apply for the Artists in Schools and Communities program now have until April 15 in the spring to apply. The program previously only accepted applicants in the fall by its September deadline.

The program provides intensive, hands-on training in all arts disciplines to students by providing funds to schools and nonprofit organizations that bring in groups and individuals for residencies. Artists are responsible for developing their residency lesson plans.

The Council says applicants should give themselves plenty of time to prepare materials. Applicants must submit several items, including an artist statement, residency outline and work samples.

#### Daugaard signs companion bill to balanced budget resolution

PIERRE, S.D. (AP) — Gov. Dennis Daugaard has signed into law a measure that would limit the authority of a constitutional convention delegate from the state.

Daugaard signed the bill on Tuesday that serves as a companion measure to a proposal that calls for a convention to amend the U.S. Constitution to require a balanced federal budget.

Opponents have said they're concerned the amendment process could backfire and be used to rewrite many parts of the Constitution.

Advocates say the bill Daugaard has signed restricts a South Dakota convention representative from approving any unauthorized amendments.

It would also require convention delegates from the state to take an oath affirming they wouldn't support a rogue amendment. It would allow up to a \$5,000 civil fine to be imposed if a delegate violated the oath.

## Fire destroys Tea business in which it started; no injuries

TEA, S.D. (AP) — A fire in Tea has destroyed the industrial building in which it started Tuesday morning.

Officials say the fire began around 9:30 a.m. at the Huck Finn Painting Company, located in an industrial area of the town. The fire is now out but burned for several hours and filled the sky with thick black smoke that could be seen for miles.

Lincoln County Emergency Management Coordinator Harold Timmerman says fire started when a woodworking machine malfunctioned.

Timmerman says the fire burned quickly because the building was filled with paint, stain and lacquer. All of the employees got out safely and no emergency responders were hurt as they spent hours fighting the flames.

#### Panel defeats plan to allowed concealed carry without permit

PIERRE, S.D. (AP) — A state Senate panel has defeated a proposal that would allow people in South Dakota to carry a concealed pistol without a permit.

The Senate Judiciary Committee voted 5-1 on Tuesday against the measure, which would have removed the requirement for a concealed pistol permit from state law.

Openly carrying a firearm in South Dakota is legal.

Republican Rep. Jim Stalzer has said that he has a concealed pistol permit and has been in situations where he's been glad to have it. But Stalzer says he knows people who have accidentally let their permits expire and have carried their weapons illegally.

The law enforcement community has opposed the proposal, which passed through the House.

Republican Sen. Phil Jensen says an effort to revive the plan Tuesday afternoon didn't receive enough support.

#### House approves proposal to overhaul conflict-of-interest law

PIERRE, S.D. (AP) — The House has approved a proposal to overhaul conflict-of-interest laws for South Dakota public employees in response to the investment-for-visa scandal that dominated last year's U.S. Senate race.

The House on Tuesday voted 67-1 for the measure, which broadens state law to prohibit state employees or officers from directly benefiting from contracts they approve.

Republican Rep. Mark Mickelson says his proposal extends that prohibition for a year after the employee leaves state government, with exceptions.

Mickelson says his proposal strengthens state law. It also extends to contracts that don't include the expenditure of public funds.

Democratic Rep. Peggy Gibson says a failed amendment she pushed to establish a state ethics commission would have helped provide a more open government.

She says the EB-5 visa scandal is still "shrouded in mystery."

#### Anti-Common Core plan fails to get full House consideration

PIERRE, S.D. (AP) — The South Dakota House of Representatives has voted to not consider a measure that would end the state's involvement in the Common Core educational standards.

The House voted 39-31 on Tuesday as part of procedural maneuvering not to schedule the bill to be on the calendar for Wednesday's floor session.

Aberdeen Republican Rep. Dan Kaiser argues the anti-Common Core measure should have been heard on the floor. He says advocates of the standards have been allowed to "propagandize" during committee.

Kaiser says it's time to make sure opponents receive a fair hearing to discuss the standards.

Republican Rep. Jacqueline Sly of Rapid City says her committee gave adequate consideration to the bill.

The proposal narrowly died in committee last week, and procedural maneuvers ultimately failed to resurrect it.

### SD delegation criticizes Obama's veto on Keystone XL pipline

SIOUX FALLS, S.D. (AP) — South Dakota's Republican congressional delegation is criticizing the president's veto of a bill to approve construction of the Keystone XL oil pipeline.

Sen. John Thune, South Dakota's senior senator, says President Barack Obama's veto is disappointing but not surprising.

The pipeline proposed by TransCanada Corp. would transport Canadian oil through Montana and South Dakota to Nebraska, where it would connect with existing pipelines to carry the oil to refineries along the Gulf Coast.

Sen. Mike Rounds says Obama has chosen to appease the "far-left wing" of his political base instead of doing what's best for Americans.

U.S. Rep. Kristi Noem says the president's decision is veto on jobs, South Dakota counties and relief for a transit system already over-crowded with oil transport.

Congressional Republicans may try to override Obama's veto.

#### House panel buys more time to review transportation funding JAMES NORD, Associated Press

PIERRE, S.D. (AP) — Concerns about long-term increases in gas taxes to help pay for South Dakota's roads and bridges prompted House lawmakers on Tuesday to buy about two more weeks to examine the issue.

The House State Affairs Committee unanimously killed its version of a transportation package in favor of a more limited Senate proposal. The move allows lawmakers to avoid a Tuesday legislative deadline for bill consideration and extend debate by taking up the Senate plan later.

House Majority Leader Brian Gosch said the committee had too many questions about the size of the tax hikes in the proposal compared with what's needed to pay for roads and bridges.

"I'm not certain if we have answers to many, many of the questions that were asked today," said Rep. Roger Solum, a Republican from Watertown. "I have some serious concerns about this."

The House plan would have raised the gas taxes 2 cents each year for 15 years, while the Senate plan would raise it 2 cents each year for eight years. Both proposals are modified versions of the transportation plan Gov. Dennis Daugaard has proposed, which raises about \$50 million in road and bridge funding in its first year through increases in fuel taxes, fees and other assessments.

Transportation funding is likely the most hotly debated issue lawmakers will consider during the 2015 session. Tax increases require two-thirds legislative support to pass.

"Does the current bill ... exceed what the need actually is?" Gosch said after the hearing. "There will be a lot more to do in the next two weeks."

The governor's director of policy and operations, Nathan Sanderson, told the committee that South Dakota's fuel tax has remained flat for years, but the state's transportation construction costs have increased significantly. The state and local governments say hundreds of millions of dollars are needed each year for repairs.

The state alone has identified an average necessary yearly spending increase of more than \$140 million to keep up with future funding requirements, Sanderson said.

The oil and gas industry opposed the longer-term increases in motor fuel taxes included in the House plan that stretched until 2030. Daugaard's original plan proposed ongoing increases in fuel taxes without a set end date, whereas the increases in the Senate plan would expire in 2023.

South Dakota Petroleum and Propane Marketers Association Executive Director Dawna Leitzke said that the annual fuel tax increases in the House proposal would have made South Dakota less competitive with surrounding states.

South Dakota's fuel taxes currently are lower or roughly on par with neighboring states, but Leitzke said the House plan would drastically change that.

Sanderson said the governor is flexible with the provisions the proposal includes as long as it addresses the state's funding needs.

"As long as we meet the need, he's not particularly concerned what the soup looks like," Sanderson said.

#### National animal nonprofit says SD justice advocate a top dog

SIOUX FALLS, S.D. (AP) — A national animal defense nonprofit has honored a Lead woman who pushed heavily to make South Dakota the last state in the nation to make animal cruelty a felony.

The Animal Legal Defense Fund has named Shari Kosel one of its Top Ten Animal Defenders for 2015. Kosel is the co-founder and chair of South Dakotans Fighting Animal Cruelty Together.

She petitioned the state Legislature for years to make malicious animal cruelty a penalty. Last year lawmakers passed a measure that reserves felony charges only for those who willfully and maliciously seek to harm animals, while keeping a misdemeanor penalty for neglect or mistreatment.

The ALDF says Kosel began pushing for tougher penalties after her neighbor's dog was tortured and murdered in 2008.

## Sioux Falls police arrest 3 teens in stolen SUV at school

SIOUX FALLS, S.D. (AP) — Police say three Sioux Falls teenagers accused of stealing an SUV and driv-

ing around the city recklessly were arrested after they dropped off a 10-year-old boy at school.

Police spokesman Sam Clemens says a woman called police Tuesday morning to report her 2001 Land Rover Discovery was missing. Police had already received a report of a similar car driving recklessly on the city's east side.

Officers found the SUV and followed it to Garfield Elementary. Police say a 10-year-old boy got out of the Land Rover and went to school.

Officers moved in and found two 14-year-old girls and a 13-year-old boy in the SUV. All three were charged with possession of a stolen vehicle.

The 10-year-old was not charged and is believed to be related to one of the girls.

#### Report: Many Dakotas college students go elsewhere to finish DAVE KOLPACK, Associated Press

FARGO, N.D. (AP) — A relatively high rate of North Dakota junior college students complete their degrees at a four-year university, according to a report released Tuesday by a group that tracks the progress of college students.

North Dakota was one five states to have more than 20 percent of its students who start at two-year colleges successfully finish at four-year schools, according to the National Student Clearinghouse Research Center study, which followed college student progress over a six-year period. Kansas led the way at 25 percent. The national average is 16 percent.

Lisa Johnson, who tracks student transfers and retention for the North Dakota University System, said the state has favorable policies for transfer students, including commonly numbered courses and a general education agreement.

"Our two-year schools are particularly attentive to academic advising and clear transfer pathways," she said.

Overall, the report shows that North Dakota and South Dakota college completion rates are relatively close to the national average. The percentage of students who earn degrees or certificates after starting at four-year schools is 64.65 percent in South Dakota and 64.61 percent in North Dakota. Of those, 13 percent of North Dakota college students and 12 percent of South Dakota students finish at a school other than where they started.

The overall completion rate in the U.S. is 62.85 percent, with 13 percent of students moving on to finish at other colleges.

Daniel Palmer, researcher for the South Dakota Board of Regents, called the report a "tremendous asset" because the numbers are more reflective of the student body than traditional studies of graduation rates.

"When we talk about graduation for our students, or anybody's students for that matter, we're only looking at the ones who completed a degree at the institution they started at," Palmer said. "We know at the same time that a lot of students are going to complete courses at multiple institutions and they're likely to finish somewhere other than where they originally started, and this confirms that."

Many North Dakota college students transfer among four-year schools and in some cases from fouryear to two-year institutions, Johnson said.

"I find the reasons for student transfer almost as unique as the student," she said. "Maybe someone they are in a relationship with transfers and they follow them; it might be job opportunities; it might be program opportunities. They just really are varied."

Palmer said that while the numbers "speak to the reality" of the situation with transfer students, the best scenario is for students to finish their educations where they started so they don't have the hassle

of transferring credits and possibly retaking classes.

"Just because a lot of students may complete somewhere else, that doesn't let us or anybody else off the hook with respect to doing our best to ensure that students are successful who do start at our institutions," he said.

## **Retail gasoline prices continue to rise in the Dakotas**

BISMARCK, N.D. (AP) — Average retail gasoline prices continue to rise in the Dakotas.

GasBuddy.com reports that the average price of a gallon of gas is about \$2.13 in South Dakota and \$2.22 in North Dakota. South Dakota's average price rose 3  $\frac{1}{2}$  cents over the past week and North Dakota's average jumped nearly 5  $\frac{1}{2}$  cents.

Gas prices in both states fell below the \$2-per-gallon mark in January as global oil prices dropped. But GasBuddy.com Senior Petroleum Analyst Patrick DeHaan says seasonal rises in gas prices are now well underway.

Gas in the Dakotas is still more than \$1 per gallon cheaper than it was a year ago, however.

### **Ex-Marine guilty of murder in 'American Sniper' trial faces** life in prison without parole

STEPHENVILLE, Texas (AP) — A Texas jury has rejected the insanity defense of a former Marine in the deaths of famed "American Sniper" author Chris Kyle and another man.

After a two-week trial in which jurors heard testimony about defendant Eddie Ray Routh's erratic behavior, including statements about anarchy, the apocalypse and pig-human hybrids, they convicted Routh Tuesday night in the deaths of Kyle and Chad Littlefield at a Texas shooting range two years ago. Routh showed no reaction as a judge sentenced him to life in prison without parole, an automatic

sentence since prosecutors didn't seek the death penalty in the capital murder case. As one of his victim's siblings called him an "American disgrace" shortly after, Routh looked back at the man intensely but didn't react otherwise.

The verdict capped an emotional trial in which prosecutors painted the 27-year-old as a troubled drug user who knew right from wrong, despite any mental illnesses. Defense attorneys said he suffered from schizophrenia and was suffering a psychotic episode at the time of the shootings. While trial testimony and evidence often included Routh making odd statements and referring to insanity, he also confessed several times, apologized for the crimes and tried to evade police after the crime.

"You took the lives of two heroes, men who tried to be a friend to you," Chad Littlefield's half brother Jerry Richardson told Routh after the verdict. "And you became an American disgrace."

## Pressure centers on House GOP on Homeland Security funding bill with partial shutdown looming

WASHINGTON (AP) — Days ahead of a looming partial agency shutdown, the pressure is on House Republicans after Senate GOP leaders agreed to Democratic demands and announced legislation to fund the Homeland Security Department without contentious immigration provisions opposed by Democrats and President Barack Obama.

Early reviews from House conservatives were negative ahead of a closed-door caucus meeting set for Wednesday morning, their first since returning from a weeklong congressional recess. Several insisted they could not accept the two-part strategy proposed by Senate Majority Leader Mitch McConnell: a vote on legislation to fund the Homeland Security Department, and a separate vote to overturn Obama's recent executive actions sparing millions of immigrants in this country illegally from deportation.

The approach "is tantamount to surrender, and won't meet with support in the people's House," said Rep. Matt Salmon, R-Ariz. "I will fight against any funding bill that does not fully defund the president's illegal actions."

Yet with a partial shutdown set to trigger at midnight Friday without congressional action, options were few for Republicans who won full control of Congress in November's midterm elections in part on promises to block Obama's immigration policies.

They could allow the agency's funding to expire, violating their leaders' promises that there would

be no more shutdowns on the GOP watch. They could try to pass a short-term extension of current funding levels, postponing the conflict to another day. Or they could go along with McConnell's strategy of funding the agency fully while registering their disapproval of Obama's immigration policies with a separate vote.

## Utah CEO pushes justice overhaul, wins government contracts while fighting repeat offenses

SALT LAKE CITY (AP) — The CEO of a Utah company that has emerged as a key player in a national movement to overhaul the justice system is a repeat offender himself.

Sean Hosman's dual roles as advocate for change and repeat visitor at county jails provide a striking case study in an expanding national effort to use insurance industry methods to help predict future crimes and steer defendants toward treatment.

His company, Assessments.com, has won 100 contracts with state and county governments from Florida to California. He has spoken at justice forums in Texas, Idaho and Washington state.

At the same time, Hosman has been arrested at least nine times since 2010, four for DUI and one for cocaine possession. Just like tens of thousands of defendants undergoing this process known as risk assessment, he has been booked, assessed, jailed and sent to rehab.

He said he has been clean since July 5, 2012, the date of his last DUI.

## Fate of abducted Christians unclear as fierce fighting continues in northeastern Syria

BEIRUT (AP) — Fierce fighting between Kurdish and Christian militiamen and Islamic State militants is continuing in northeastern Syria where the extremist group recently abducted at least 70 Christians. Hassakeh province which borders Turkey and Iraq is the latest stage for the fight against IS. The group overran a cluster of villages nestled along the Khabur River on Monday, seizing dozens of Christians, many of them women and children.

Thousands of others fled to safer areas.

The fate of those kidnapped was still unclear Wednesday, two days after they were seized.

The Britain-based Syrian Observatory for Human Rights and a Christian group called the Syriac Military Council said heavy clashes against IS militants in the area are continuing.

## Thailand's multibillion-dollar seafood industry plagued by pirates and slaves on high seas

SAMUT SAKHON, Thailand (AP) — Urine pools under a bed where an emaciated Burmese man lies wearing only a T-shirt and a diaper.

As he struggles to sit up and steady himself, he tears at his thick, dark hair in agitation. He cannot walk and doesn't remember his family or even his own name. He speaks mostly gibberish in broken Indonesian — a language he learned while working in the country as a slave aboard a Thai fishing boat.

Near death from a lack of proper food, he was rescued from a tiny island in Indonesia two months ago. He is just one of countless hidden casualties from the fishing industry in Thailand, the world's third-largest seafood exporter.

A report released Wednesday by the British nonprofit Environmental Justice Foundation said that

overfishing and the use of illegal and undocumented trawlers have ravaged Thailand's marine ecosystems and depleted fish stocks. Boats are now catching about 85 percent less than what they brought in 50 years ago, making it "one of the most overfished regions on the planet," the report said.

Shrinking fisheries in the Gulf of Thailand and Andaman Sea have, in turn, pushed Thai fishing boats farther and farther from home. The group estimates that up to half of all fish labeled a "product of Thailand" is sourced from outside its borders — mainly in Asia, but as far away as Africa.

### Iran's Revolutionary Guard attacks mock US aircraft carrier in drill near strategic strait

TEHRAN, Iran (AP) — Iran's Revolutionary Guard launched large-scale naval and air defense drills near a strategic Gulf waterway on Wednesday in which dozens of speedboats swarmed a replica of a U.S. aircraft carrier.

The drill, named Great Prophet 9, was held near the Strait of Hormuz, through which one fifth of the world's oil passes. Iran's regular army carried out naval drills near the strait in December.

State TV showed footage of missiles fired from the coast and the fast boats striking the mock U.S. aircraft carrier. The drills, which also included shooting down a drone and planting undersea mines, were the first to involve a replica of a U.S. carrier.

"American aircraft carriers are very big ammunition depots housing a lot of missiles, rockets, torpedoes and everything else," the Guard's navy chief, Adm. Ali Fadavi, said on state TV, adding that a direct hit by a missile could set off a large secondary explosion. Last month Fadavi said his force is capable of sinking American aircraft carriers in the event of war.

The Guard's chief commander, Gen. Mohammad Ali Jafari, said the drills send a "message of (Iran's) might" to "extraterritorial powers," a reference to the United States.

### Candidates try to woo weary, wary voters in Britain's most unpredictable election

ATHERSTONE, England (AP) — Posters are being printed and slogans are being polished as Britain's politicians battle it out in the most unpredictable national election in decades. One top election analyst has dubbed it "the lottery election."

Voters, though, don't seem very excited about who gets the prize.

"There's nobody who can run a country. They all lie to us," said Victor Loach, a fishmonger selling his wares in the cobbled central square of Atherstone, 100 miles (160 kilometers) northwest of London. "And why do they shout at each other like children?"

It's a common refrain. Opinion polls suggest voters are lukewarm about both Prime Minister David Cameron's Conservatives, seeking a second term, and Ed Miliband's opposition Labour Party.

So who is going to win the May 7 vote?

## Chicago Mayor Emanuel gears up for runoff for re-election against County Commissioner Garcia

CHICAGO (AP) — After failing to persuade a majority of Chicago voters to back his re-election bid, Mayor Rahm Emanuel could face an even stiffer challenge in April against a runoff opponent aiming to consolidate the support of residents unhappy with how the former White House chief of staff has

managed the nation's third-largest city.

In a race Tuesday against four challengers, Emanuel discovered it wasn't enough to spend millions of dollars on TV ads, earn the backing of the city's business leaders, and secure the hometown endorsement of President Barack Obama. In order to keep the job, he'll need to win another race in six weeks against Jesus "Chuy" Garcia, a Cook County commissioner who claims the backing of teachers, unions and neighborhood residents disillusioned with Emanuel.

Emanuel pledged to rev up campaigning immediately, starting Wednesday morning by shaking hands with residents at Chicago Transit Authority stops.

"We will get back out there, talking to our friends and families and neighbors as they make a critical choice about who has the strength, who has the leadership, who has the ideas to move this great city forward," Emanuel told supporters Tuesday evening.

But Garcia and his supporters said they'd be ready for another contest, with national groups poised to weigh in on the mayor's race.

## As HSBC chiefs prepare testify in UK, questions over whether some banks too big to manage

LONDON (AP) — First there was money laundering. Then foreign-exchange rigging. Now tax evasion. HSBC, Europe's biggest bank, has endured a string of scandals — and paid millions in penalties to regulators around the world. But recent revelations that its Swiss private bank helped the wealthy evade taxes are raising new questions about HSBC's conduct and shining a spotlight on an industry still reeling from the 2008 financial crisis.

Politicians and analysts are asking whether big banks, which during the crisis were considered to be too large to be allowed to fail without endangering the wider economy, have also become too big to manage.

"If they're too big to fail, they're too big to control," said Crawford Spence, a professor of accounting at Warwick Business School. "But are they too big to bludgeon into corporate responsibility?"

HSBC Chairman Douglas Flint and Chief Executive Stuart Gulliver may get the chance to answer that question Wednesday, when the U.K. Parliament's Treasury Committee grills them about allegations that HSBC's Swiss private bank actively marketed tax avoidance schemes that helped as many as 1,000 Britons evade taxes.

## Without hate crime, US limited in prosecuting Zimmerman because he wasn't a police officer

MIAMI (AP) — The Justice Department's decision to not prosecute a civilian neighborhood watch volunteer for a hate crime in the shooting death of an unarmed black teenager is not necessarily a harbinger of how it will rule in two other high-profile deaths of unarmed black men at the hands of police officers, legal experts say.

That is because the standards used to gauge the existence of a hate crime committed by civilians are different from those used to measure the behavior of police officers, who can be charged with depriving someone of their civil rights by using excessive force in the course of duty.

Because George Zimmerman was not a police officer, the U.S. Justice Department could only prosecute him for fatally shooting teenager Trayvon Martin nearly three years ago if it had sufficient evidence the killing was motivated by racial bias or hatred, the experts say.

Zimmerman was a neighborhood watch volunteer in Sanford, Florida, without any legal authority associated with law enforcement officers. Zimmerman claimed he shot the 17-year-old Martin in self-defense, and he was acquitted by a jury in July 2013 of second-degree murder.

If he had been a sworn officer, federal prosecutors would have the option of pursuing "color of law" charges against Zimmerman. It is this kind of federal case that could be brought against officers in recent contentious killings by white police officers of black suspects Michael Brown in Ferguson, Missouri, and Eric Garner in New York.

Look over the documents on the list below, and if you have any questions at all, anything you don't understand or any documents you aren't sure you can find, please contact the Driver Licensing Pro-

gram. You may email DPSLicensingInfo@state.sd.us (please include your first and last name) or call toll-free at 1-800-952-3696 or directly at 605-773-6883.

If you think you will have difficulty obtaining any of the documents please contact us. We may be able to arrange for an extension or a temporary permit while you gather the documents needed to obtain your federally compliant South Dakota driver license or identification card. If you find that you simply can't produce one of the required documents, we can work with you in those situations. Again, please use the contact information for the Driver Licensing Program if you have any questions or concerns.

The need to show the additional documents is a one-time requirement. That means once you have your federally compliant driver license or identification card in hand, you will only need that card and two documents to show your current address the next time you renew your driver license or identification card. If your driver license or identification card has a gold star in the upper right corner, then it is federally compliant.

Federal regulations require anyone applying for a new, renewal, or duplicate driver license or identification card to provide the documents listed below and on page 2 (photo copies are not acceptable):

I. You will need one Identity Document. NOTE: If your name is different than the name on your identity document, you will need to bring additional proof of your legal name. Acceptable documents for proof of a legal name change are a certified marriage certificate (issued by a state vital records agency), a certified adoption document, or a certified court order authorizing a name change (such as a divorce decree). If you have had multiple marriages, you will need to bring similar documents providing legal proof of each name change (presenting a valid passport with your current name eliminates this requirement).

An Identity Document to prove identity, date of birth, and lawful status is considered to be one of the following:

• Certified U.S. birth certificate issued by state or county (hospital birth certificates are not acceptable)

- Valid unexpired U.S. passport
- Certificate of Naturalization
- Certificate of Citizenship

Non-Citizens may bring:

- Valid unexpired permanent resident card
- Valid unexpired employment authorization document
- Foreign passport with valid unexpired U.S. Visa with I-94

#### Address Exceptions:

<u>Minors</u> - If a minor does not have two documents proving residency, the parent may provide two forms for them.

<u>Living with someone else</u> - An individual residing with another person may have the other person sign a "Consent for Use of South Dakota Address" form and present two residency documents belonging to the person with whom they reside. The <u>Consent for Use of Address</u> form may be obtained at the exam station or printed off our website.

<u>Living within an organization or at a facility</u> - Applicants may provide a letter from the organization or facility (on their letterhead) stating the individual resides there.

<u>People who travel full-time</u> - If you are using a mail forwarding address, you must complete the Residency Affidavit. You will also need to provide one document no more than one year old proving your temporary South Dakota address (campground or RV park receipt) and one document no more than one year old proving your personal mailbox (PMB) service address (receipt from the PMB business or a piece of mail with your PMB address on it). <u>Military and Military Dependents</u> - Applicants can use an out-of-state address on their license and provide two documents proving residency showing the out-of-state address.

Before your license or ID card is issued, our examiners will review your documents to make sure they comply with the federal requirements. We will work with you to resolve any problems with your documents and to identify any additional documents or other information that may be necessary to complete the process. The additional requirements are designed to establish a more secure driver license, which will address our shared concern about national security, identity theft and highway safety.

#### Veterans

Veterans who have been honorably discharged from the military have the option of adding the word "Veteran" to the front of their South Dakota driver license or identification card. In addition to the documents listed above, they will need to present:

- DD-214 form which shows their honorable discharge status from active duty or
- Present a certificate signed by a county or tribal veteran's service officer verifying their status.
- DD Form 2 (Retired)
- DD Form 2A (Reserve Retired)

Note to CDL holders: If you are required to carry a medical examiners certificate (aka DOT medical card) you must show a valid card at the driver exam station.
