The City of Groton is currently applying for a federal tree grant where, if approved, the citv would get \$1,000 towards the purchase of new trees. Bev Sombke from the Groton Garden Club met with the city council Monday night and informed them that the club has \$900 that they would like to give to the city to be earmarked for new trees. The federal grant is a matching grant so the \$900 would be applied to the city's share part and the remaining \$100 will come from the general fund. The council graciously accepted the gift.

Twenty-one evergreen trees were moved at the Groton Cemetery and moved to the north side at \$75 each. It was well under budget.

Ken's of Groton is expanding

According to Lionel Bruemmer, manager of Ken's Food Fair of Groton, the Groton store will be adding 4,000 square feet of store space. The C store will be expanded and the frozen and fresh food areas will also be enlarged. He said that 17 additional freezer doors will be added. "It's going to be real nice," Bruemmer. "Groton has a real nice grocery store."

Part of the Crossroads Plaza was purchased with most of it being added to the Ken's store. "There is a small section left over that someone can rent," Bruemmer said. The grocery store and C Store areas will be separated in the new design. The grocery store part will be closed off in the early morning and late evening hours. Some essentials like milk and bread will be available in the C store area.

"We're waiting for the equipment," Bruemmer said. The flooring will be done and a fresh coat of paint will be done. The process will take six to eight weeks to complete.



Very Dry and Warm March

March 2015 was a very warm and dry month across central and northeast South Dakota as well as west central Minnesota. Average temperatures were from 4 to 7 degrees above normal for the month. The average high temperatures across the region were from 7 to 13 degrees above normal. Locations in central and north central South Dakota were among the top ten warmest on record. Pierre had their second warmest average high temperature for March along with Timber Lake. Mobridge and Kennebec had their third warmest average high temperature on record. There was a large range from the highest to the lowest temperatures for March with below zero readings early on to the very warm readings in mid and late March. Differences between the high and low temperatures across the region ranged from 80 to over 100 degrees. Kennebec had a difference of 102 degrees with a low of 19 below zero on March 5th and a high of 83 degrees on March 15th.

The area was also very dry throughout March with precipitation departures across the region generally from three-guarters to an inch below normal. As a result, moderate drought conditions expanded across northeast South Dakota and west central Minnesota throughout March with abnormally dry conditions spreading out west. Several locations had one of their top ten driest March's on record. Aberdeen and Mobridge tied for the tenth driest while Timber Lake had their fourth driest March on record. Timber Lake and Mobridge also tied for their second and third least snowfalls on record, respectively, with only a trace of snowfall.

One-third of teaching candidates placed outside South Dakota

One out of three teaching candidates who graduated from a South Dakota college or university recently took an out-of-state position.

The latest collection of data from South Dakota's higher education institutions by the South Dakota School Administrators (SASD) revealed 260 of the more than 770 graduates who obtained an education related degree were placed in a position out-of-state.

SASD's latest survey comes after a study in November found the number of South Dakota teachers eligible for retirement exceeds the number of students enrolled in teacher education programs.

"This information is scary," SASD Executive Director Rob Monson said. "We suspected this to be true, but now the data shows we're losing potential teachers to other states. already know we don't have enough candidates to replace retirees. When you look at over 1,100 educators eligible for retirement, 726 in the teacher pipeline, and 1/3 of those being placed out of state, we are in trouble in preparing our K-12 students here in South Dakota for their future, and the future of the South Dakota workforce."

An additional 52 graduates chose to do something besides teaching, according to the figures provided.

"Nearly forty percent of our new graduates aren't going into South Dakota classrooms," Monson said. "South Dakota is running out of teachers."

SASD began compiling data last year on the teacher shortage facing South Dakota school districts, finding that one in five schools started the school year without a teacher in a classroom and 1/2 of S.D. districts cited salary, relocation – many to districts in other states – or a change in profession as reasons given by teachers who left South Dakota schools.


"Who's going to educate our kids? That's the guestion we need to be asking right now," Monson said. "The data continues to show we've reached a critical point where we need to address that question."

The K-12 community will have help answering that question when Gov. Dennis Daugaard's Blue Ribbon Task Force convenes.

"Gov. Daugaard's previous studies of adult and juvenile justice, as well as roads produced impactful legislation and we're optimistic the Blue Ribbon Task Force will do the same," Monson said.

The task force will examine the teacher shortage, as well as school funding and student achievement, and will be comprised of stakeholders in education.

"We have a crisis in our schools," ASBSD Executive Director Wade Pogany said. "We need everyone to come together and commit to finding solutions for the shortage. Our schools can't afford for us to wait any longer."






