# Permanent substitute teacher considered

Groton Area Superintendent Joe Schwan has come up with an idea of having a permanent substitute teacher. He said that currently, the principals are dealing with substitute teachers at least two hours each day. "The full time substitute would alleviate that issue," Schwan said. It would cost the district an additional \$10,000 a year and the big challenge is finding the right person to fill the spot. The board agreed it would be a good idea if the right candidate can be found.

Rachel Crank came before the board Monday night to ask for a waiver or reduction in fees to use the gym for an exercise program in the event the weather outside is not good. The fee schedule is set at \$300 for the Arena and \$150 for the gym. The board decided to set a rate of \$25 for an hour of use of the gym.

The school's ICU program is showing huge signs of success. In a report by MS/HS Principal Anna Schwan, not a single student failed a course in the spring semester with the help of the ICU program.

Schwan reported that the Class of 2015 has accepted \$530,485 in scholarships at the time of graduation.

So far, 15 students are enrolled class for this fall.

No rate increase from Delta Dental. "That will be good news for the staff," said Business Manager Mike Weber.

The capital outlay budget was reviewed. There are a number of items which include carpet in some rooms, ceiling fans, parking lot work, shelving, switching to IP cameras, etc.

LED lights are being installed in the Arena.

The track will be resurfaced in the next couple of weeks.

Sidewalk installed at football field to connect the concession stand, bathrooms and the bleachers. Also in the plans is the sound system for the football field.



The Groton Area School Board gave approval for a new scoreboard at the football/track field at Monday night's meeting. The new scoreboard will be located in the northwest corner of the football field, outside of the track. The project is expected to cost \$47,677. Superintendent Joe Schwan also proposed three options for selling the advertising spaces. He said that he would like to see it being a perpetual source of revenue. Business Manager Mike Weber said if that were to happen, the district would need someone to oversee it and to make sure the money comes in. Weber said he would like to see it being sold once and then it's done. The proposed funding package is for a period of five years and would generate anywhere from \$30,000 to \$45,000, depending on the package the board adopts. The first option is that the 4'x4' ad space would be \$1,500 a year for five years and the 30"x54" ad under the scoreboard would be \$750 a year for five years. This option would generate \$45,000 over five years.

The only comment from the board about the scoreboard was the color. "Do they realize that we are not orange and black?" asked Board Member Marty Weismantel.

The project will be done this summer and ready for the football season.

The school calendar was amended. The big change was moving the prom date from April 23 to April 16. in at least one on-line dual credit Homecoming was also set with coronation on September 21 and the game with Roncalli on September 25.

It appears the district will be switching banks in January 2016. Wells Fargo Bank is the current bank, but the fee structure is costing the district money. That's because the interest earned was reduced from .6 percent to .4 percent and the going rate right now is .2 percent. "We're not getting enough interest to pay for the fees," said Weber said. The Super Now account at the First State Bank has no fees and they pay .1 percent interest up to \$50,000 and .2 percent anything over \$50,000. Over the course of the year, the district will be making more than \$3,000 from the interest with no fees. The board will make the official bank designations at the annual meeting in July.

Kelsey Hunt resigned as the basketball cheerleader coach for the 2015-16 school year. Open enrollments were approved for a first grader and a freshman from Aberdeen.

# Huron USPS plant won't close July 11

A few weeks ago it was reported that the Dakota Central mail processing center at Huron would close July 11 and the work would be consolidated into the Sioux Falls mail processing center.

Now it appears the Huron facility will not close July 11. Last week the Postal Service announced it was slowing the schedule for closing and consolidating various mail processing plants around the country, including the Huron plant.

The change is in response to a flood of recent criticism the USPS has received from the National Newspaper Association and other major mailers.

This is a release issued last week by NNA:

In response to complaints by National Newspaper Association and many mailers, the U.S. Postal Service has changed its planned schedule for consolidating and closing many mail processing plants this year. Although USPS insists the intention to proceed with the network changes remains, the pace of change has slowed significantly. Many closings that had firm July-September dates now have 'To Be Determined' notations.

Rural senators led by Sens. Jon Tester, D-Mont., and Heidi Heitkamp, D-N.D., are pushing hard for Congress to enact a postal reform bill that will keep the plants open.

NNA Postal Committee Chair Max Heath requests that members report chronic breakdowns in service to NNA. Current closing and consolidation schedule as of May 27, 2015, is available here.

The municipal tax changes taking effect next month include:

Columbia, S.D., imposing a two percent general sales and use tax rate

Westport, S.D., imposing a two percent general sales and use tax rate.

South Dakota municipalities are able to implement new tax rates or change existing tax rates on Jan. 1st or July 1st each year.



The Andover, S.D. native is a 2014 animal science major. Schuring was raised on a dairy operation. As an under-




# Girls Cross Country to run the same as Boys Cross Country – Meet Distance: Change the distance for SDHSAA Region and State Girls'

Cross Country – Meet Distance: Change the distance for Si Cross Country to 5,000 meters to match the boys' distance.

Rationale as follows:

Within the past three years, several states have faced legal/discrimination charges for restricting female student athletes to a shorter competition distance in the sport of cross country. Beginning in 2015, only three states are currently set to have males and females run different distances – North Dakota, Kansas and South Dakota – with both North Dakota and Kansas also considering making the change to the same distance for each gender. Texas and Oklahoma, meanwhile, run a full 5K course for their male and female competitors at all levels except for their smallest schools. This means that 46 of the 51 State Associations currently run either a 5K or three-mile course for both boys and girls in all post-season competition.



RELATED INSTRUMENTS.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUN-CIL OF THE CITY OF GROTON, BROWN COUNTY, SOUTH DA-KOTA:

Section 1. Ratification of Prior Actions and Declaration of Necessity. All actions heretofore taken (not inconsistent with the provisions of this Resolution) by the Council and by the officers of the City directed toward the issuance of the bonds are hereby ratified, approved and confirmed. The City hereby declares a necessity to issue Special Assessment Bonds, Series 2015.

Section 2. Issuance of Special Assessment Bonds. To provide funds to pay the costs of the improvements, the City shall issue, without a vote to its electors, its registered bonds, in an aggregate principal amount not to exceed \$165,000, to be issued in full conformity with the provisions of SDCL Chapters 9-43 and 6-8B. The Bonds shall be issued in lieu of Special Assessment Certificates and shall be payable solely from special assessments made against property benefited from the Improvements. The bonds do not constitute a debt within the meaning of Article XIII Section 4 of the Constitution of the State of South Dakota.

2.1. Date and Denomination of Bonds. The bonds will be dated in 2015 and shall also bear the date of authentication, shall be in fully registered form shall be on such terms and conditions as are determined by the Mayor and Finance Officer, shall be numbered 1 and upward, and the bonds shall become due and payable as determined by the Mayor and Finance Officer.

2.2. Interest and Principal Payments. The bonds shall bear interest at a rate not to exceed 3.95% from their date or from the most recent interest payment date to which interest has been paid or duly provided

for, until the principal amount of the bonds is paid, such interest (computed upon the basis of a 360-day year of twelve 30-day months) being payable as determined by the Mayor and Finance Interest on each bond shall be paid by check, draft or wire transfer of the Finance Officer, Groton, South Dakota, hereby designated as the Bond Registrar and Paying Agent, payable in lawful money of the United States of America, to the person in whose name such bond is registered at the close of business on the last day of the month next preceding the interest payment date. The principal of the bonds shall be payable in lawful money of the United States of America at the principal office of the Bond Registrar.

Section 3. Redemption. All Bonds are redeemable prior to maturity in whole, or in part, at the option of the City. All bonds are redeemable pursuant to SDCL Chapter 6-8B. Prior to any redemption date, the City shall deposit with the Bond Registrar an amount of money sufficient to pay the redemption price of all the bonds or portions of bonds which are to be redeemed on that date.

Section 4. Authentication. All bonds shall have thereon a certificate of authentication substantially in the form hereinafter set forth duly executed by the Bond Registrar as authenticating agent of the City and showing the date of authentication. No bond shall be valid or obligatory for any purpose or be entitled to any security or benefit under this resolution unless and until such certificates of authentication shall have been duly executed by the Bond Registrar by manual signature, and such certificate of authentication upon any such bond shall be conclusive evidence that such bond has been authenticated and delivered under this resolution. The certificate of authentication on any bond shall be deemed to have been executed by the Bond Registrar if signed by an authorized officer of the Bond Registrar, but it shall not be necessary that the same officer sign the certificate of authentication on all of the

Section 5. Registration of bonds; persons treated as owners. The City shall cause books (the "Bond Registrar") for the registration and for the transfer of the bonds as provided in this resolution to be kept at the principal office of the Bond Registrar, which is hereby constituted and appointed the registrar of the City. The City is authorized to prépare, and the Bond Registrar shall keep custody of, multiple bond blanks executed by the City for use in the transfer and exchange of bonds.

Section 6. Form of Bond. The Bonds shall be prepared in substantially the form on file with the Finance Officer.

Section 7. Sale of Bonds. The Mayor and Municipal Finance Officer are authorized to sell said bonds upon terms and conditions not inconsistent with this resolution to First State Bank or their designee. The Finance Officer shall deliver upon receipt of the purchase price therefore; the Bonds to said purchaser. The bonds shall be purchased for a price not less than 100%.

Prior to the delivery of any of the bonds, the Municipal Finance Officer shall execute a certificate describing the improvements (by number) which are to be financed by the proceeds of the bonds being delivered, stating the amount of unpaid assessments for such improvements, and stating that said assessments have been appropriated and pledged to the bond fund hereby created.

section 8. Creation of Bond Fund. The proceeds of the bonds, including accrued interest thereon, upon receipt thereof, shall be deposited promptly by the Municipal Finance Officer and shall be accounted for in the following manner and are hereby pledged therefore:

8.1. Accrued interest received for the bonds shall be deposited in the Special Assessment Bonds, Series 2015, Bond Fund (the "Bond Fund") which is hereby created for the payment of the principal of and interest on the bonds. The accrued interest and funds deposited by the City at the time of the delivery of the bonds, shall be used for the first installment of interest on the bonds; and

8.2. The balance of such proceeds shall be credited to the improvement account created by the Finance Officer to pay the costs of, or reimburse the City for the costs of, the improvements.

Section 9. Covenants of Tax

Exemption. The City hereby covenants for the benefit of each holder of the bonds that:

9.1. Bond proceeds and other sums credited to the improvement account shall not be invested in such manner as to result in the loss of exemption from federal income taxation of interest on the bonds;

9.2. The City shall make no use of the proceeds of the bonds which, if such use had been reasonably expected on the date of the issue of the bonds, would have caused them or could cause the governmental obligations of any subsequent issue to be "arbitrage bonds" under Section 103(b) of the Internal Revenue Code of 1986, as amended (the "Code") and the applicable regulations thereunder; and the City and its officer, employees and other agents shall take appropriate action so that on the basis of the facts, estimates and circumstances in existence on the date of issue of the bonds it is reasonably expected that the proceeds of the bonds will be used in a manner that will not cause the bonds nor the governmental obligations of any subsequent issue to be such taxable "arbitrage bonds"; and

taxable "arbitrage bonds"; and 9.3. The City certifies the following:

9.3.1. The Bonds are being issued for a valid essential governmental purpose and are not "private activity bonds" as defined by the Code. None of the proceeds of the Bonds will be used to make or finance loans to any person. The City does not anticipate issuing more than \$5,000,000 in tax exempt obligations during the current calendar year. The Bonds are "qualified tax exempt obligations" as described by the Code.

The Special Assessment Bond Fund 2015 (hereafter "Bond Fund") is hereby For the purpose of providing the necessary funds to make required payments of principal of and interest on the bonds, the City hereby irrevocably pledges all amounts derived from special assessments for all improvements and all moneys in the Bond Fund. No moneys may be transferred out of the fund until all obligations which are or may be charged against the Bond Fund have been discharged.

10.1. Deposit of Assessments into Bond Fund. Such assessments as created by Resolution 14-818 passed by the City on

June 1, 2015, when collected and received by the City, shall be deposited immediately into the Bond Fund. In the event the amount in the Bond Fund is insufficient to pay all principal and interest when due, such amount shall first be used to pay any past due interest and then in pro rata payment of current interest. Any balance shall be paid on bonds issued hereunder in order of serial numbers; provided that no bondholder shall be compelled to accept partial payment on any bond.

Section 11. Event Constituting Default. In event of nonpayment of principal or interest on any of the bonds, such action shall constitute a default as to all bonds and shall enable the holders of any or all outstanding bonds, whether or not the same shall be due, acting individually or collectively, to take such action as they may deem necessary to protect the security of their bonds.

Section 12. Registered Form. The City recognizes that Section 149(a) of the Code requires the bonds to be issued and to remain in fully registered form in order that interest thereon is exempt from federal income taxation under laws in force at the time the bonds are delivered. In this connection, the City agrees that it will not take any action to permit the bonds to be issued in, or converted into, bearer or coupon form.

Section 13. List of Bondholders. The Bond Registrar shall maintain a list of the names and addresses of the holders of all bonds and upon transfer shall add the name and address of the new bondholder and eliminate the name and address of the transferor bondholder.

Section 14. Authorization to Furnish Information. The Municipal Finance Officer is authorized and directed to furnish to bond counsel certified copies of all proceedings and records of the City relating to the bonds and to the improvements financed thereby and to the right and power of the City to make the assessments securing payment of the bonds and all said certified copies and certificates shall be deemed representative of the City as to the facts therein stated.

Section 15. Authorization to Take Action. The Mayor and Finance Officer of the City are hereby authorized and directed to take all other action necessary or appropriate to effectuate the provisions of this resolution, including without limiting the generality of the foregoing, negotiating the final terms of the sale, the printing of the bonds, and the execution of such

certificates as may reasonably be required, including, without limitation, certification relating to the signing of the bonds, the tenure and identity of the City's officials, the exemption of interest on the bonds from federal income taxation, the receipt of the bond purchase price and, if in accordance with the facts, the absence of litigation affecting the validity thereof.

Section 16. Resolution Constitutes Contract. After the bonds have been issued, this resolution shall constitute a contract between the City and the holder or holders of the bonds, and shall be and remain irrepealable and unalterable until the bonds and the interest accruing thereon shall have been duly paid, satisfied and discharged.

Section 17. This resolution shall become effective immediately upon its passage.
