Doug Sombke Elected to Serve Sixth Term as South Dakota Farmers Union

HURON, S.D. - Doug Sombke was elected by the members of South Dakota Farmers Union to serve a sixth term during the organization's centennial conven- tion held in Huron Dec. 9 and 10, 2015.

"I feel truly honored to serve the membership of this great organization - these are South Dakota's farmers, ranchers and rural citizens," explained Sombke, a fourth generation Conde crop and cattle farmer who has served as the organization's President since 2005. Serving more than 17,000 family farmers, ranchers & rural citizens statewide as president of one of South Dakota's largest agriculture organizations, Sombke spends his days traveling across the state and nation advocating for family farms, ranches and rural communities, while his three now-grown sons manage the day-to-day farming operations of the family farm. All three sons also operate



independent businesses which helps the farm sustain four families.

"It's the next generation of young farmers and ranchers who inspire me - our state's economic future rests in their hands because agriculture is our number one industry. They are the reason I put my all into this role each and every day," Sombke explains. "When I was rst asked to serve as President 10 years ago, the timing could not have been better. My sons were ready to become more active on the farm."

Since becoming President 10 years ago, the organizations' membership numbers have soared, reaching a 20-year high of 17,000 in 2015.

"Membership numbers increased in nearly every county throughout South Dakota - this is a clear sign that our organization is not only strong, but growing," says Karla Hofhenke, S.D. Farmers Union Executive Secretary.

Hofhenke that as a grassroots organization, she and the rest of the state staff are led by Sombke and a board of agriculture producers. During state convention, three board members were also reelected. These members include; Wayne Soren, SDFU Vice President, Lake Preston; Jim Wahl, Salem; Lynn Frey, Lemmon; and Joel Keierleber, Colome.

Two Groton Area wrestlers went to the Lamoure Wrestling Tournament on Saturday and both came home as champions. "It was another great day for the Groton wrestlers at the Lamoure tournament this past weekend," said Coach Dana Dargatz.

"Trevor pray bumped up a weight class and did so in fashion defeating all of his opponents to claim the individual title, beating the #5 ranked wrestler in North Dakota 2-0," Dargatz said. Trevor wrestled at 126 pounds, pinning Riley Griffin of Mandan, 1:10, then he pinned Ethan Curruth of Ellendale-Edgeley-Kulm, 1:24, and in the championship match, he decisioned Darin Vangorkom of South Border, 2-0, scoring a two-point take-down in the second period.

"Brandyn Anderson kept on his winning ways also by winning the individual title as well, and wrestled a very smart and controlled championship match 7-1," Dargatz said.

Anderson, in heavyweight, pinned Riley Mattheis of Linton, in 43 seconds, then he pinned Travis Patterson of Bishop Ryan in 2:59, he pinned Seth Strong of Ellendale-Edgeley-Kulm, in 55 seconds, and in the championship match, he decisioned Lonnie Rodlund of Tiospa Zina, 7-1.

"I'm very pleased with how things went this weekend," Dargatz said. "We wrestled very smart, stayed in great position the whole day and the boys' efforts showed. It's really nice to see them performing so well this early in the year." Groton Area will be at the Northeast Conference Tourney next Saturday at Milbank. It starts at 11 a.m.





The lift station has needed repair work in the last month. There seems to be an excess of grease build up. The city is asking residents not to pour grease down the drain. Mike Wilson will be cleaning up the lift station on a monthly basis to keep the floats clean of that grease.

The new water rates were discussed and will go into effect once all of the new water meters have been replaced. The new base will be \$45.00 and the per gallon rate will be \$3.75 and overage gallons will be \$5.50. The wooden playground equipment will be torn down as it is no longer safe to play on. The city will look at other ways to replace the play area. A pancake fundraiser was suggested. The city is in the process of starting a waste water project. Each water meter will be inspected at time of removal. If there is a large discrepancy with what had been reported and what the meter is reading, that finding will be reported to the board. 


