Harder, Gengerke and Fjelstad earn spots on school board

Incumbent Merle Harder wins re-election to 2nd term on the Groton Area School Board. Newcomers Deborah Gengerke and Clint Fjelstad earn two other seats vacated by current board members Dorene Nelson and Lars Hanson, who choose not to run.

Corey Mitchell's eight (8) vote difference for the final seat narrowly missed state statute allowing a recount within a 2% margin, based on total number of ballots cast (325).

SDCL 13-7-19.3. Close margin in school election – Petition for recount – Appointment of recount board.

A recount shall be conducted when, within five days after completion of the official canvass of a school district regular or special election at which a question is approved or disapproved by a margin not exceeding two percent of the total votes cast in the election, any three registered voters of the school district file a petition duly verified by them, setting forth that they believe a recount will change the outcome. A recount board shall be appointed by the business manager who shall appoint one person on each side of the question and one person who shall be mutually agreed upon by the other two appointed.

Jan reported that Fireworks are not insurable with the city insurance. She also stated it would cost \$345.00 for Softball/Baseball insurance. The consensus was that the City should put up a sign at the ballpark and state that the "City is not responsible for accidents".

The city is also looking into graveling the road on the corner of County road 10 and County road 9 where the storm sewer was fixed.

Jan Ellefson resigned from the board. Mike accepted the resignation and Shane seconded it. Mike then nominated Tim Selzler to the board and Shane seconded it.

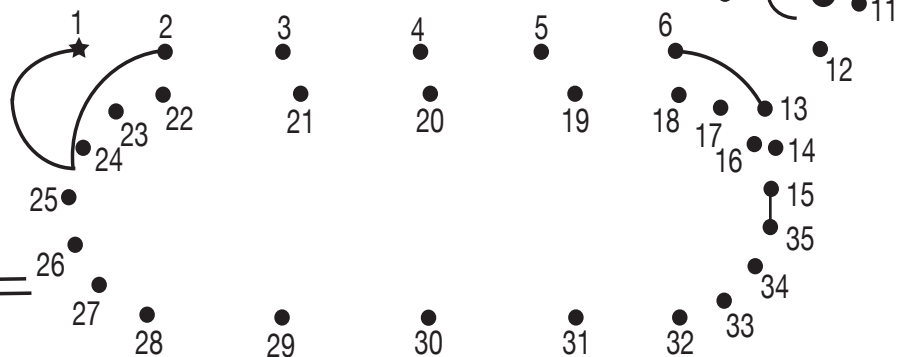
