Elementary School nearing completion Work on the Groton Area Elementary School

is nearing completion. The janitorial staff has begun work in the building and some stuff has been moved in. Superintendent Joe Schwan said that he knows the elementary staff is itching to move into the building. He did say that maybe, and only maybe, that could happen as early as next Monday. Schwan said that he would send out an e-mail letting the staff know when they can move into the building. To date, only 69.3 percent of the contingency fund has been used.

Another school has joined the North Central Special Education Co-Op. Edmunds Central becomes the ninth school to join Doland, Frederick Area, Groton Area, Hitchcock-Tulare, Langford Area, Leola, Northwestern Area and Warner.

A number of positions were filled at the school board meeting last night. Melissa Ulmer will be the new elementary librarian;

Lisa Sippel was hired to replace Joni Groeblinghoff as a special education teacher. Groeblinghoff moved to the kindergarten aid replacing Alexia Schuring. Schuring moved to the junior kindergarten teacher, replacing Kayla Krause who left.

In other staff changes, Jodi Schwan is the new Opportunities Room Counselor replacing Kiersten Sombke who is the new middle/high school principal; Deb Tietz, Rita Kampa and Karen Johnson are all part-time cooks; Chris Kucker and Doug Heinrich are volunteer assistant girls soccer coaches; Sara Schuster is the volunteer assistant volleyball coach; and Seth Erickson is the volunteer assistant football coach.

The board approved the extension of the Safe Routes to School Grant. It was earlier approved by the city council and also has to be approved by the school. The plan is to get a speed sign for around the school.

The board acknowledged the receipt of an application for public school exemption for a sixth grader, and approved the open enrollment for an eighth grader from the Aberdeen Public School District.

There was



Groton Area Elementary Renovations and Addition Updates

Progress Update 08-14-2017 By Superintendent Joe Schwan

Each week at our weekly construction progress meetings attended by Ken Anderson (FJJ), Joel Bornhoft (FJJ), and each contractor, we discuss jobsite safety, clean-up, critical items (security), change events, Field Work Orders*, Requests for Information (RFis)**, Supplemental Instructions (ASis)***, schedule reviews, equipment deliveries, manpower updates, and anything else of importance.

*Field Work Orders: As of last week, there have been 17 approved field work orders, all of which have been completed.

These are minor work orders outside of the scope of a contract that need to be completed on the spot and will likely result in a change order being processed at some point.

**Requests for Information: As of last week, there had been 87 RFis submitted to be responded to by the responsible party, typically the architect or an appropriate engineer.

***Supplemental instructions: As of last week, five ASis have been issued.

Work Remaining:

1992 Addition/Library/Center: Work remaining in this area of the building is very minor. There are a few doors in this area to install (expected to arrive to jobsite on Tuesday, 8/15/17) -JDH. Vinyl base needs to be installed in the computer Lab - Grazzini Brothers. Muth Electric is finishing the data wiring termination in the hub room.

Our custodial crew has been in this area cleaning carpets and will strip/wax the tile floor in the junior kindergarten room. We are expecting to begin moving items back into this space beginning Tuesday, 8/15/17.

Lower Pod: Interior doors need to be installed. Carpeting needs to be finished extending from the PLC into to hallway and ceiling tiles need to be dropped in the hallway. Anything else in this area is basically a punch-list type item.

Upper Pod: Interior doors need to be installed. Carpeting needs to be installed in two more classrooms as well as in the PLC and into the hallway. Carpeting will be followed by rubber base. Ceiling tiles need to be dropped in the upper pod. Trim and sealing of the windows is in progress as well.

Main Restrooms/Kitchen/Gym: Most of the remaining work on the renovation is in the restrooms and kitchen. The dish counter is expected back on site Tuesday. The kitchen is ready for ceiling grid, followed by light fixtures, HVAC and sprinkler connections and ceiling tile. The girls bathroom has been tiled/grouted and the plumbers are beginning to hang fixtures. Ceiling grid is scheduled for Wednesday after which time partitions, light fixtures, and HVAC connections can be completed. The boys bathroom has been tiled and the grout is curing. Ceiling grid is scheduled for this space late on Wednesday followed by the same protocol as in the girls restroom (with fewer partitions).

New Addition: I expect that conversation at our weekly meeting on 8/16/17 will begin to center around work taking place in the new addition as contractors begin to shift focus back to that area.

Miscellaneous: We've begun discussion with FJJ and the contractors about taking back our playground space prior to the beginning of the school year- similar to how it was set up last spring.

I've had discussions with Mr. Clocksene about the alternative options for serving lunch during the completion of the construction of the new addition. During that time, lunch will be served in the gymnasium as it has in the past.

Next week Tuesday (August 22), there is a walk through with the Architects and Engineers to develop the punch list of items that need to be completed and/or corrected. It is anticipated that many of these items will be completed prior to school beginning on September 5. Those items not yet completed will need to be taken care of around our school day schedule







Boards of North Central Farmers Elevator and Wheat Growers Approve Member Vote on Unification

(AUGUST 14, 2017; Ipswich & Aberdeen, SD) - The Boards of Directors for North Central Farmers Elevator (NCFE) and Wheat Growers have decided to proceed to a vote of the membership to unify the two cooperatives. Both boards voted affirmatively to sign a Unification Agreement that would unify the two cooperatives, subject to a vote of the memberships of both cooperatives.

"The value to our members is what's driving the decision by the Boards to move forward with also heard from Sheriff's offices that they have the effort to unify the two cooperatives," said Rick Osterday, NCFE Board President. "Members have told us that unification will help us be better able to compete at a time when we see lots of competitor growth in the region. This will help keep our businesses strong, members' equity secure, and local control intact."

Osterday said the decisions to take the unification opportunity to a vote of the memberships was made after considering member feedback and re-examining findings from a thorough analysis of both cooperatives that was conducted two years ago. The unification proposal now will be considered by the memberships of both cooperatives.

"Many benefits we've identified are extremely timely given the aggressive positioning of competitors and continued market uncertainty," said Hal Clemensen, Wheat Growers Board President. "By combining both cooperatives, we can realize significant savings, economies of size and scale, efficiencies in operations, adoption of new technologies, and an ability to continue to attract talent – all to better serve our members."

A series of member information meetings will be held throughout the region beginning Aug. 21. Ballots will be mailed to members of NCFE and Wheat Growers on Aug. 29. Details regarding member information meetings, ballots, and how and when members can vote will be provided to members over the next few weeks.

Weekly Vikings Roundup **By Jordan Wright**

The Minnesota Vikings won their first preseason game on Thursday, August 10, defeating the Buffalo Bills 17-10. Even though it was a preseason game, it's still nice to see the team getting a win. Head coach Mike Zimmer is a competitive coach



who hates losing, even in the preseason, where he is 13-1 through his first four seasons in Minnesota. As happy as he was to get the win, Zimmer was still disappointed in his team's performance, remarking "My expectation for this team is a lot higher than that and so we got to get back to work."

Three big questions after the first preseason

How did the offensive line look? The biggest question heading into this season (and for the past few seasons) is whether the offensive line can provide protection to quarterback Sam Bradford and open running lanes for Minnesota's very capable running backs. The simple answer? The offensive line looks as bad in 2017 as it did in 2016. Newly acquired right tackle Mike Remmers gave up a sack within the first three minutes of the game, stalling the Vikings' first offensive drive and forcing the team to punt.

The silver lining? The Vikings were without their other shiny new offensive tackle, with Riley Reiff sitting because he's coming back from an injury suffered in training camp. It's possible the Vikings' first-team offensive line will look a lot better once he is back (although I'm not holding my breath). There were also two rookies who looked like they might develop into good players. Pat Elflein, the center who the Vikings drafted in the third round, had a very solid performance. He did have one bad snap, but other than that he looked very good. Danny Isadora, a guard who the Vikings took in the fifth round, had a nastiness in college and it showed up against the Bills. There is a good chance both these rookies will be needed this season, and so far they have shown they'll be up to the task.

How did Dalvin Cook perform? The running back position is going through some major changes in 2017. Everyone knows the Vikings released Adrian Peterson this offseason, then proceeded to use their first draft pick (second round) on his replacement, Dalvin Cook. Ev-

eryone was curious to see how Cook would perform, and his first game in purple and gold didn't disappoint. Cook ran the ball for only 13 yards on five carries, but it was his versatility that really shone through. He also caught the ball four times (on four targets) for 30 yards. Cook appears to have the strength to run between the tackles, the speed to run outside the tackles, and the ability to catch the ball out of the backfield. With Bradford's penchant for checking down, Cook's ability to catch and run makes him a valuable member of the offense.


Which players, who are fighting to make the team, stood out? NFL teams have two goals in the preseason: getting the starters ready for the regular season, and filling out the rest of the roster. Every year, there are players who seemingly come out of nowhere. There were a couple players on the team who really stood out (although everything in the preseason needs to be taken with a grain of salt). Tashawn Bower has been talked about all training camp, and he didn't disappoint against the Bills. Bower finished the game with two tackles, a sack, a tackle for a loss, a pass deflection, and two quarterback hits. He reminds me of another LSU prospect who was considered "raw" coming out of college: Danielle Hunter. If Bower continues this production, there is no way the Vikings will be able to sneak him onto the practice squad.

Another player who stood out was Stacy Coley, a wide receiver the Vikings drafted in the seventh round of the draft. Coley led the team with 67 yards receiving. All three of Coley's catches were impressive, and he's starting to earn his spot as the team's fifth receiver.

Looking ahead, the Vikings travel to Seattle to battle the Seahawks on Friday, August 18. The starters should play most of the first half, so we will get a better idea of how good (or bad) the starting offensive line will be this season.

Drought Monitor



August 8

Hit-and-miss rainfall throughout the High Plains brought changes in this week's Drought Monitor to every state. In east central North Dakota, abnormally dry conditions (D0) were expanded because of continued rainfall deficits and reports of crops showing signs of drought stress. The entire state now has some level of dry/drought depiction. While other parts of the state received beneficial rainfall, it was typically just enough to "string crops along" and keep drought conditions from further deterioration in these areas. The only exception was a small area of improvement to the extreme drought (D3) conditions in the south

central part of the state along the South Dakota border. This area has consistently received above-average rainfall and has 30-day totals in excess of 200 percent of normal.

South Dakota also saw a mix of improvements and degradations due to the spotty nature of last week's rains. Locally heavy rainfall brought a full category improvement to an approximate one-to-two county wide band extending from northeast to central South Dakota. Counties along the southwestern edge of South Dakota's drought-afflicted region missed out on the rains and saw an expansion of moderate and severe drought. The tri-state area of South Dakota, Nebraska, and Iowa also saw an expansion of severe drought (D2) conditions as rainfall deficits grew and crops began to see stress. However, Nebraska saw improvements on this week's map. Locally heavy rainfall of 3-plus inches brought improvements to the abnormally dry (D0) areas in the northwest and southeast part of the state and the moderate (D1) and/or severe drought (D2) in the southwest and north central regions. Counties in eastern Kansas received a month's worth of precipitation in one week, erasing abnormally dry conditions. Central Kansas saw an expansion of moderate drought (D1) as continued rainfall deficits dried out soils, lowered streamflow, and stressed vegetation.

When Mama's Not Happy, Nobody's Happy.

Nurture versus nature is a question often bandied about. Is it the environment in which the child is raised, or is it the genetics provided by the biological parents, that most influences what kind of person a child will grow to be?

We have known for a long time that if a parent is depressed, their children are at higher risk for having anxiety, depression, and disruptive behavior. Indeed, the offspring of de-

problems when compared to the children of parents who are not depressed. So, is it because of the environment; or is it genetics?

Research published in the Journal of the American Medical Association brings us closer to an answer. It is important to note that the study consisted primarily of mothers with depression, as they are far more likely pressed parents have to report symptoms up to a three-times and come in for treat-

higher risk of these ment than fathers with depression. However, researchers believe that their discovery applies to whichever parent has depression, regardless of whether they are male or female. The results were fascinating: effective treatment of the mother lead to resolution of psychiatric problems in the child.

Study author Myrna Weissman, professor of psychiatry and epidemiology at Columbia University, said "while depression may be a genetic disorder, [this study showed that] a parent's illness has a very strong environmental

effect on her child." In other words, when mama's not happy, nobody's happy. Weissman also pointed out "if you have a depressed mother, you ought to do everything you can to get her better, because there's a double effect that will impact their children."

I think the message from this research is very powerful, and should be taken to heart by any mother or father. If you as a parent are having psychological trouble, get help and your child will be better for it. If you won't do it for yourself, do it for your kids.






