Groton Area heads to the Sweet 16

It was exciting volleyball action Thursday night in the Groton Area arena as it was a rematch between Groton Area and Milbank for the rite to advance to the Sweet 16 round. After losing the first game, 25-23, the Tigers rallied to win the next three games, 25-13, 25-18 and 25-22

to win the match.

The match was carried live on GDILIVE.COM, sponsord by the Aberdeen Chrysler Center.

Molly Rick dominated the first game for Milbank with seven kills. The Bulldogs jumped out to a 5-1 lead. Groton Area would rally to tie the game at 14, 15 and 16 before taking the lead at 21-18. Milbank came back to tie the game at 22 and 23 and scored the last two points to win the game, 25-23.

Jennie Doeden four ace serves, three blocks and a kill to help lead Groton Area to the second game win. The Tigers jumped out to an 8-0 lead and Milbank never threatened as the Tigers easily won game two, 25-13.

Groton Area jumped out to a 4-0 third game lead, but Milbank tied the game at nine and took the lead. The game was tied five times and the lead changed hands four times. Groton Area had a rally of four straight points to take a 19-17 lead. Milbank closed to

within one, 19-18, but would remain scoreless for the rest of the game. The game ended with Miranda Hanson having three straight ace serves and Nicole Marzahn having the game winning kill for the final, 25-18. Payton Colestock had four kills and an ace serve in the game while Marzahn and Doeden each had three kills and Gia Gengerke had two blocks.

The fourth game was intense and fierce with the game being tied eight times and the lead changed hands four times. Each team had the biggest lead of the game at three points. Marzahn had the game winning kill to give Groton the 25-22 win. Gengerke had five kills, an ace serve and a block in the final game and Marzahn had three kills for the leaders.

"It was definitely a hard fought win for us and a definite confidence booster moving into the sweet 16!" said Coach Chelsea Hanson. "We had everyone contributing tonight with four girls having right around 10 kills each!" The Tigers were 184 of 201 in attacks with 43 kills. Gia Gengerke

was 36 of 40 with 12 kills, Jennie Doeden was 42 of 49 with 11 kills, Nicole Marzahn was 41 of 42 with 10 kills and Payton Colestock had eight kills."

we really kept our heads in it and competed and for that I'm very proud!" Hanson said. "We also hit a milestone. I've never had it where we went 106-106 from the service line with 8 aces, that's huge. "A missed served is a definite momentum killer and I'm glad we stayed

focused back there." Jennie Doeden was 24 of 24 with two ace serves, Miranda Hanson was 14 of 14 with three ace serves and Gia Gengerke was 21 of 21 with two ace serves. "It's really the one part of the game that never changes and we have total control over so we should do well with those things."

We will have McCook/Montrose in the sweet 16, so now it's time to start preparing for them!" Groton Area was 173 of 174 in sets with 36 assists. Miranda Hanson was 149 of 150 with 32 assists and Payton Maine was 12 of 12 with three assists. The Tigers had 135 digs with Maine having 30, Doeden 25 and Jessica Bierke 20. In blocks, Gengerke had four solo and one assisted block, Doeden had three blocks and Jessica Bjerke had one block. Milbank had three missed serves with Jaecy Engebretson having 2 two ace serves. Molly Rick was 72 of 78 in attacks with 25 kills






It was not a Sweet 16

"The season didn't end the way we wanted it to end," said Coach Chelsea Hanson after the Lady Tigers lost a hard fought battle to the McCook Central-Montrose Fighting Cougars in the Sweet 16. Groton won the first game, but Morgan Koepsell and McKenna Kranz played hard ball and it caused problems for the Tigers. The two Fighting Cougars hit the bill hard and often and Koepsell's height didn't help the Tiger cause either. The Fighting Cougars won the match, 3-1.

Groton won the first game, 25-23, with a game that was tied four times and there were three lead changes before the Tigers rallied to take a 20-14 lead. McCook Central-Montrose closed to within one, 22-21, and after a Groton Area time-out, the Tigers put the game away with the two point win.

The Fighting Cougars jumped out to a 6-0 lead in the second game. Groton closed to within two, 7-5, but after that, it was McCook Central-Montrose going for the 25-16 win.

McCook Central-Montrose jumped out to a 4-0 lead in the third game and went on several rallies to post a 25-17 win.

Groton Area kept the game close for the first part of the match with the game being tied five times and there were two lead changes. Groton led, 9-8, but the Fighting Cougars went ahead, 12-9. The Fighting Cougars held a 21-15 lead before Groton got a rally going to close the game to within two, 21-19, before McCook Central-Montrose called time out. It was 22-21 before the Fighting Cougars scored the last three points to post the 25-21 win.

" I couldn't be any more proud of the way we competed at the match and all season," Hanson said. "There were so many positives this season that it makes the sting of defeat a little less. We won the conference, made it to the Sweet 16, and ended the season with the most wins (18-6 record) since I've been here for sure and possibly in school history. We had some great senior leadership and we will miss them very much next season, they're part of the Groton Volleyball family forever, and when we make a state tournament they can take pride knowing they were part of it! I'm sad to have the season over, but it was sure a lot of fun for all of us!"







Weekly Vikings Roundup

The Minnesota Vikings got a chance to rest this past weekend, as the team was in their bye week. The Vikings have played eight games so far this season, with six wins and two losses. The team will look to use this week off to get some players healthy, and to re-focus their efforts so they can make a playoff push. The Vikings will also look to avoid collapsing after the bye week like they did last season, when the team was 5-0 entering the bye week and ended the season 8-8.

Since Mike Zimmer took over the reigns as head coach, the Vikings are a team that relies on defense to win most games. The Vikings offense has taken a big step forward this season, however, and are ranked 11th in the NFL with 358.5 yards per game. The team is also

13th in points per game, scoring an average of 22.4 per contest. For the first time in what seems like forever, the Vikings have a good passing attack – even though most of the season has been with Case Keenum, the team's third string quarterback, at the helm. The Vikings are 14th in the NFL with 238.5 passing yards per game. Last season, the Vikings were a dink and dunk team, meaning they would consistently throw short, easy passes. That has changed this year, as the team is tied for 14th in yards per attempt at 7.2. The team is throwing deeper passes, which are riskier, but there are only three teams in the NFL who have thrown for less than the Vikings' three interceptions.

Defense is where the Vikings really shine, and this year has been Zimmer's best season yet. The defense is 4th in the NFL, only allowing 282.1 yards per game. The team is also third in the league in points allowed, only giving up 16.9 points per game. One big reason for Minnesota's success on defense is how stingy they are on third downs, where they are the second-best team in the NFL – they only give up third downs to opposing offenses 28 percent of the time. The Vikings haven't been getting as many turnovers this year – they only have seven interceptions (15th in the league) and four forced fumbles (28th) – but that's ok when they are only giving up a league best of 4.6 yards per play.

The Vikings have one of the best defenses in the NFL, and now that they have a competent offense to match, the team has their eyes set firmly on bringing home it's second league championship and first Lombardi Trophy.

The offensive MVP though the first half has to be Adam Thielen. At the halfway point of the season, Thielen has 627 yards and a touchdown, which would give him 1,254 for the season if he maintains his current pace. That would be the most receiving yards for a Minnesota Viking since Sidney Rice had 1,312 in 2009 when Brett Farve was slinging the pigskin for the purple and gold.

The defensive MVP so far is Everson Griffen, who has 10 sacks and two forced fumbles through eight games. Griffen has a sack in every game so far this season, which ties an NFL record. He is a one-man wrecking crew along the Vikings defensive line, and even though other teams are game planning to stop him, he is still creating havoc. Griffen is also the emotional leader of the defense, and sets the tone both in games and in every practice.

Looking ahead, the Vikings will play the Washington Redskins (4-4), Los Angeles Rams (6-2), Detroit Lions (3-4), Atlanta Falcons (4-4), Carolina Panthers (6-2), Cincinnati Bengals (3-5), Green Bay Packers (4-3), and the Chicago Bears (3-5).

There is no doubt the Vikings schedule gets more difficult after the break. The Rams are suddenly the hottest offense in the league, the Lions have already beaten the Vikings, the Falcons and Panthers are the two most recent NFC Champions, and the Packers might have Aaron Rodgers back by the time the Vikings face them again in week 16. While the schedule may be getting tougher, the Vikings have some good news to look forward to with the return of Teddy Bridgewater. If the Vikings can get Bridgewater back and he picks up where he left off (which admittedly is a big question mark), the Vikings should be the favorites to win their remaining games.

This season is already half over, and it has been a wild ride so far, but the team is far from finished and has big dreams that are within reach. So strap in, because the second half of the season is shaping up to be even better, and will hopefully end with the Vikings playing in the Super Bowl in front of the home crowd at U.S. Bank Stadium. Skol!
