Shabazz has double-double in win over Patriots

Three players hit double figures Tuesday night as the Groton Area Boys' Basketball team improved to 2-1 on the season with a 66-32 win over Hitchcock-Tulare.

Seric Shabazz had a double-double on the night with 11 points and 10 rebounds. Brodyn DeHoet led the Tigers with 15 points while Jonathan Doeden and Shabazz each had 11, Treyton Diegel made three-three-pointers for nine points, Anthony Sippel had six, Marshall Lane five, Kaden Kurtz and Cade Guthmiller each had three points, Peyton Johnson had two and Austin Jones added one point.

The Tigers made 42 percent of their field goals while the Patriots made 24 percent. Hitchcock-Tulare had 27 turnovers, 15 of which were steals with Brandon Keith and Seric Shabazz each having five. Groton Area had 22 turnovers of which 11 were steals with Ty Hofer having four.

The Tigers had the edge on the boards, 48-29. Groton Area made 15 of 30 free throws off of the Patriots' 26 team fouls while Hitchcock-Tulare made seven of 14 free throws off of Groton Area's 16 team fouls.

Zach Binger led the Patriots in scoring with eight points and Ty Hofer had seven.

Groton Area won the junior varsity game, 42-14. Scoring for the Tigers were Cade Guthmiller with 10, Kaden Kurtz eight, Darien Shabazz, Austin Jones and Jackson Cogley each had five points, Peyton Johnson, Riley Thurston and Lucas Simon each had three.

It will be a Thursday-Friday scheduled for the basketball teams as the boys host Redfield-Doland on Thursday and the girls travel to Redfield on Friday.

Weekly Vikings Roundup **By Jordan Wright**

The Minnesota Vikings traveled to Charlotte riding an eight-game win streak and had a chance to lock up the NFC North with a win against the Panthers. The Vikings would have also locked up the division with losses by both the Green Bay Packers and Detroit Lions. Unfortunately for the Vikings, none of those things happened on Sunday.

There were plenty of reasons that the Vikings didn't play well on Sunday, but it really all started up front along the offensive line. The problems started before the opening kickoff when rookie center Pat Elflein was ruled out of the game with a shoulder injury. His absence forced left guard Nick Easton to play center and Jeremiah Sirles to come off the bench to play left guard. Combined with the continued



absence of right tackle Mike Remmers, the Vikings had three offensive linemen playing out of position. The mid-game injury to left tackle Riley Reiff was the icing on the cake, and at that point it didn't matter what the Vikings did, it was nearly impossible to overcome those disadvantages.

Case Keenum did not have a good game, which was directly related to the offensive line woes. He threw for 280 yards, but it took him 44 pass attempts to get there (a measly 6.36 yards per attempt). Keenum produced two touchdowns, but he also threw two interceptions, fumbled the ball once, and took six drive-stalling sacks. This loss isn't entirely on Keenum, as the offensive line had their worst game of the season, but he is clearly unable to overcome obstacles and put the team on his back when it's needed the most.

To make matters worse, the Vikings were unable to get much going in the run game against the Panthers. They were forced to throw the ball so much, they were only able to run the ball 21 times. They managed to produce 100 yards on those 21 carries (4.8 yards per carry), but it wasn't enough to keep the offense balanced, which allowed Carolina to pin their ears back on defense and get after the guarterback.

With the offense struggling, the Vikings defense was needed to put the clamps down and keep this game within reach. Unfortunately, they were unable to do that on Sunday. For the first time all season, the Vikings defense gave up a 100-yard rusher, with Jonathan Stewart rushing for 103 yards on 16 carries. The Panthers as a team had 216 rushing yards, which allowed them to control the game and keep the Vikings offense off the field. The Vikings defense limited Cam Newton to only 137 passing yards, one touchdown and one interception, but Newtown was able to put the game away with a 62-yard scramble in the fourth guarter.

At the end of the day, the Vikings are still 10-3 and are in great position leading into the playoffs. The Carolina Panthers are a tough team to beat, especially in their home stadium, and the Vikings found that out the hard way. If the Vikings' offensive line was at full strength, I'm sure the game would have been much closer – but injuries are part of the game and must be overcome, which didn't happen on Sunday. Both the offense and the defense played subpar, and the Vikings are no longer the number one seed in the NFC as a result.

Looking ahead, the Vikings return home and will take on the Cincinnati Bengals on Sunday, December 17. The game will start at noon central time and will be shown on CBS. ESPN has the Vikings as heavy favorites in the game, giving them an 81% chance to win. The Bengals are 5-8 this season and will be coming off an embarrassing 33-7 loss to the Chicago Bears. If the Vikings can shut down Bengals wide receiver A.J. Green, the Vikings should have no problem winning this game. Skol!



The South Dakota Corn Utilization Council (SDCUC) is a progressive organization which has visionary and influential producer leadership throughout the state. The 9-member board manages and invests South Dakota's 1-cent per bushel corn checkoff fund.
