

## **Quality Rural Health Care with Less Burnout**

The elderly patient came back to our rural hospital from a hospital in a nearby larger city after having had major surgery and feeding-tube placement. The care from the bigger hospital was superb except that the patient was getting too much nutrient and fluids and was a bit "overloaded." Also, the

been too aggressive in getting stressful surgery for their elderly mom, whose memory



had begun to slip. As her physician, I cut back on the feeding-tube supplements, stopped the intravenous fluids, provided a little diuretic and did labs and X-ray for dementia. I took plenty of time with family and patient learning about their wishes should our patient again deteriorate. All agreed to emphasize comfort from here on out, and if she started to fail, we would do our best in her home hospital and not transfer her care again.

I had been that patient's primary care doc for years. Practicing outpatient and inpatient care in a smaller town gave me the experience to see what was happening. The patient and family knew me, trusted me and appreciated the time I spent listening to her. Quality care reviewers, government oversight people and insurance companies also know the value of a well-trained rural primary care provider who not only understands how to care for complex patients, but also, knows when and where to refer when specialized care is needed. In fact, experts believe an ideal system would define a primary care provider for every person.

Unfortunately, there are not enough rural primary care docs. Many speculate as to why this is; however, I believe the need has resulted from misinformed med students and residents who think the lifestyle in rural America is not satisfying enough. In the July 2019 issue of South Dakota Medicine, a survey of family physicians practicing in this state found much lower burnout rates in family docs practicing in rural areas (25 percent) compared with those practicing in larger metropolitan areas (51 percent). Evidently, some social aspects of rural practice seem to confer a protective effect against burnout. This new data should be helpful when young physicians are looking for the most satisfying places to practice.

# Bordewyk named executive director of South Dakota News Watch

David Bordewyk, a widely respected media leader for the past 25 years, is joining South Dakota News Watch as its executive director effective Nov. 1, 2019, the nonprofit organization announced.

Bordewyk, a Brookings, S.D., resident, is the longtime executive director of the South Dakota Newspaper Association. A 1984 journalism graduate of South Dakota State University, Bordewyk has been a strong voice for government transparency and a leader in efforts to strengthen citizen access to public information.

"With his deep knowledge of the state, its people and issues, Dave is exactly the right person to lead South Dakota News Watch into the future," said Randell Beck, board co-chair and, with Jack Marsh, co-founder of the independent journalism organization dedicated to producing in-depth stories about statewide topics. "Dave is a trusted leader committed to our mission to serve the public interest with firstrate reporting."

In a unique partnership with the oldest media organization in the state, Bordewyk also will continue in his role as executive director of the South Dakota Newspaper Association. SDNA, based in Brookings, has represented South Dakota newspapers for 137 years.

"Reliable investigative journalism on topics that impact our citizens on a broader state-wide scale is paramount to the success and growth of our state, but it was missing here until South Dakota News Watch launched in February 2018," said Letitia Lister, publisher and part-owner of the Black Hills Pioneer in Spearfish.

"It is with great hope for the future of journalism that our South Dakota Newspaper Association looks upon this new partnership with the professional journalists at South Dakota News Watch," said Lister, current board president of SDNA. "Information is power and America needs journalists."

## **Co-ops Support Summer Study** Recommendation

PIERRE, S.D. – South Dakota's electric cooperatives applaud an interim committee of the South Dakota Legislature for supporting a framework for a compromise which has the potential to bring long-needed improvements to electric service territory disputes.

An exception in current state law allows the 35 municipal electric systems in South Dakota to take territory in newly annexed areas from electric cooperatives and investor-owned utilities. That exception has been the focus of the nine-member Electric Services in an Annexed area legislative summer study committee for the past five months.

The framework of the compromise that was adopted on an 8-1 vote by the legislative committee on November 6 would require regular meetings and good faith negotiations between all utilities involved in electric service territory boundaries in newly annexed areas. The compromise framework further states that if the utilities cannot negotiate an agreement as to who will serve the newly annexed areas the Public Utilities Commission would settle the dispute.

'The framework of a compromise that was overwhelmingly adopted by the legislative summer study committee is a good start to law governing electric service territory," South South Dakota electric cooperatives have been telling lawmakers for the past year that it is fundamentally unfair for municipal electric systems to have the option to take service territory from another utility. The proposal passed by the nine-member legislative committee provides a path forward to solve this problem. "This legislative committee spent a lot of time and effort to adopt this plan and we would like to thank them for their work," Anderson said. South Dakota's electric cooperatives would especially like to thank Sen. Alan Solano (R-Rapid City) for chairing the committee and Rep. Thomas Brunner (R-Nisland) for serving as vice-chair of the panel. Co-ops would also like to recognize Sen. Susan Wismer (D-Britton), Sen. Jordan Youngberg (R-Madison), Rep. Shawn Bordeaux (D-Mission), Rep. Kirk Chaffee (R-Whitewood), Rep. Spencer Gosch (R-Glenham), and Rep. Tim Reed (R-Brookings) for supporting the compromise.


