COVID-19 information keeps changing, but the goal is to get the kids back to school

Information is changing by the week and day on the COVID-19 virus and its impact on the upcoming school year. Superintendent Joe Schwan told the board of education Monday night that the "expectation is to get the kids back to school as often as possible. It will come down to "How" and not "if."

The district is still awaiting guidance for sporting events and the music department. "I anticipate different rules for different sports," Schwan said. "There are a lot of different groups meeting and everyone acknowledges to get the kids back to school."

North Dakota is proposing closing school for three days on the first positive case, and two weeks for the second positive case and two weeks for each additional positive case thereafter. "If we get something like that, then we'll be out of school more than we'll be in school," Schwan said.

Tigh Fliehs suggested starting school earlier - like August 13th. Schwan said the board would have to make any adjustments to the school calendars its July meeting. Schwan is going to make a proposed calendar for the board to review. Board member Grant Rix said that the elementary school students are starting out behind so it's important to get as much in-classroom time as possible. Board member Deb Gengerke said there will be options for everyone. "It won't be perfect and we'll have to adjust," she said.

Students will now need to be fever-free without medication for three days instead of one as it is now. "That's a big difference from where we were at last year," Schwan said.

Middle/High School Principal Kristen Sombke said with the dual credit situation, it is important that the students check their emails.

Business Manager Mike Weber said there is about \$80,000 in surplus due to many factors with no school being held in the spring. Such savings include not running the bus routes, teacher substitutes, no travel for track or golf, etc.

There were a number of fund transfers to balance the budget to close out the school year.

The district has to set up a budget for the CARES ACT ESSER program. The district is expected to receive \$94,110 in COVID-19 related funds. The district could attempt to collect around \$84,000 in COVID-19 related wages that were paid out from the CARES ACT and then carry the balance over to the next year. It would reflect wages being paid for auxiliary staff from March 13 to May 22. Nothing will be collected for special ed money due to federal regulations.

Health Department Awards \$500,000 For Mosquito Control

PIERRE, S.D. – More than 200 South Dakota cities, counties and tribes will share in \$500,000 in grants intended to control mosquitoes and prevent West Nile virus (WNV), the Department of Health announced today.

"South Dakota has a disproportionately high number of WNV cases when compared to other states. Local mosquito control efforts play a vital role in protecting our communities," said Bill Chalcraft, administrator of public health preparedness and response for the Department of Health.

All applying communities received funding, with grants ranging from \$500 to \$20,000. Grant awards were based on the population of the applying jurisdiction and its history of human WNV cases through 2019.

Since its first human WNV case in 2001, the state has reported 2,612 human cases and 46 deaths. Every county has reported cases.

Including this latest round of grants, the state has provided local mosquito control programs with more than \$8.5 million in support, in either direct grant funding or control chemicals, since the virus emerged in South Dakota. Groton is one of many communities in South Dakota being awarded

Experts express optimism on future of small towns during virtual town hall discussion

Editor's note: This story is part of a series of articles by South Dakota News Watch called, "Small Towns, Big Challenges" that is examining small towns from a historical perspective and looking forward through the lens of the COVID-19 pandemic.

Optimism for the future of South Dakota's small towns — and resilience in overcoming obstacles to stability and growth — were the main takeaways from a virtual town hall meeting held June 25 as part of an ongoing South Dakota News Watch series examining the past, present and future of small towns and how they have been affected by COVID-19.

One goal of the project was to spark in-depth conversations about how to keep small towns stable and vibrant. In an effort to kickstart those conversations, News Watch assembled a group of four panelists, each with a unique perspective on small-town vitality, to discuss the challenges and opportunities facing small towns via video conference.

The discussion was broadcast live through Facebook and Zoom; the event drew roughly 60 attendees and as of June 29, more than 1,100 people had viewed all or a portion of a recording of the event.

The meeting's four panelists included: Travis Anderberg, owner of the Rexall Drug store in Miller, S.D.; Tawney Brunsch, executive director of Lakota Funds, a community development financial institution on the Pine Ridge Indian Reservation; Ben Winchester, a rural sociologist with the University of Minnesota Extension Service who studies small towns; and Thomas Worsley, president of Spearfish Hospital and Hills Markets for Monument Health.

The wide ranging, hour-long discussion covered topics such as the challenges facing farmers and ranchers, the lack of housing in rural small towns, ideas for job-creation and economic revitalization, challenges in providing access to health care and services such as high-speed internet. Throughout the discussion, all four panelists acknowledged that small towns face significant hurdles, but all expressed optimism that solutions to problems can be found and that once the COVID-19 pandemic subsides, rural communities will be able to grow and thrive.

"I am very, very positive," Worsley said. "Small communities come together, they get things done, they have a can-do attitude, they have a resolve, they don't rely upon external forces to come in and solve problems for them. They tend to come together and see what's possible rather than what the limitations are so, I share the optimism of the group."

Winchester challenged the notion that small towns were at risk prior to the pandemic. Data from the U.S. Census and other sources show that many of South Dakota's small towns have struggled for generations with slowly declining populations, a lack of economic opportunity and, more recently, sharp drops in the prices of grain and cattle. Health statistics also show that rural residents have higher rates of death from illnesses like cancer, heart disease and accidents than their urban counterparts. Despite those issues, Winchester said, small towns are stronger than they appear at first glance.

"The population, actually, for rural communities across the U.S. has gone up by 11% since 1970," Winchester said. "We've diversified our economy well beyond where we were 50 years ago, which is really a good thing when we weather economic hits. We're not so prone to having an entire Main Street decimated because the single industry takes a hit. We're much more diversified here today."

Even before the pandemic, there had been a nationwide trend of people moving from cities to small, rural communities among Americans aged 30 to 49, Winchester said. In fact, one of the challenges for small town economic development is providing adequate housing to those who want to relocate.

"If small towns are dying, then why can't I find a home to buy?" Winchester asked.

Lack of housing is one of the biggest problems for small-town economic development. Existing housing is either worn or expensive, and developers find it difficult to build new homes in rural communities, a fact that Anderberg's home town of Miller has experienced. About seven years ago, the city of Miller commissioned a housing study and learned that the city needed to shore up its housing stock, Anderberg said.

"We went around and identified about 30 dilapidated properties and took the procedures to clear those out to provide room for building other (homes) or putting Governor's Houses on those lots," Anderberg said. "We had people redo apartments and sometimes fix up those dilapidated properties and make them rent-able."

The Governor's Home Program is run by the South Dakota Housing Development authority and uses prisoners to build low-cost modular houses to provide affordable, single-family housing units in communities for families in need.

Housing is a big issue on the Pine Ridge reservation too, Brunsch said. Reservation communities have been short of adequate housing for decades but the money needed to address the issue has been hard to come by. Federal funds don't go far enough and private investment has been spotty, if not nonexistent, Brunsch said.

"We're going to need some help to be able to fully address all of these needs at the level

that we need to," Brunsch said.

The pandemic has made the lack of housing in reservation communities an even bigger problem. In some cases there are more than 10 people living in a single 1,200 square-foot home, Brunsch said. Such tight quarters can lead to fast transmission of COVID-19.

"How do you isolate when you're sleeping with two other kids?" Brunsch said. "It's just impossible. And so it's more about a safety issue now as well, and it needs to be dealt with immediately."

The attention the pandemic has focused on the housing crisis may wind up helping solve the problem. COVID-19 may end up serving as a rallying point for reservation communities. Already, the crisis has caused philanthropic foundations to redirect financial support to efforts aimed at combating the virus and fixing other long-term challenges, such as food insecurity, that also have been given new attention due to the pandemic.

"I'm happy to say that it's creating partnerships where we're able to leverage other resources," Brunsch said.

Brunsch said the despite historical challenges to growth on South Dakota reservations, that strong hope remains for a bright future.

"I have every confidence that our small communities are only going to continue to get stronger. I think this pandemic has helped make us appreciate smaller communities more," Brunsch said. "We're stronger. We're more committed. I think we're more unified and hopefully we're going to be more focused on addressing the needs of our community, to not only strengthen the economy, but to also provide better housing and a better lifestyle for its residents."

Access to health care is another major issue getting some renewed focus in reservation communities, but also in small towns across South Dakota. Rural health care providers are suffering from many of the same issues affecting the towns they serve. The shrinking and aging populations mean there are fewer patients to treat. Meanwhile, a lack of certain amenities has made recruiting doctors and nurses harder for rural hospitals, Worsley said.

But new technologies that could help improve access to care for rural residents have been getting renewed attention and support during the pandemic. Telemedicine, or virtual doctor visits delivered via video conference through the internet, have been given new, more broad coverage by Medicare, for exam-

ple. Usually, when Medicare covers something, private insurers aren't far behind.

Telemedicine has been in development for years and many health systems already had the ability to provide virtual doctor visits, Worsley said. The problem, though, is that not all rural communities have the high-speed internet access needed for strong connectivity.

"There were folks that being able to have a virtual visit was not something that was available to them because of that reason," Worsley said.

High-speed internet has the potential to help solve a number of the challenges facing small towns. During the pandemic, the necessity of fast internet access has only increased as students began taking classes online and more businesses have come to rely on remote workers and online marketplaces to sell goods, Worsley said.

"As you start thinking about, as others have alluded to, access to education and encouraging businesses to be located in these small towns, you start thinking about high-speed internet, more like a utility like water, like all

of the other utilities that we enjoy and take for granted," Worsley said. "Because for education, health care, viability of business, it can't be overstated how important [internet] is."

Some communities already have started treating internet access with more urgency, Winchester said. In Minnesota, co-ops have been created to deliver the latest in high-speed internet technology to rural residents. In Pine Ridge, the Oglala Sioux Tribal Council is seeking to use the airwaves to wirelessly broadcast high-speed internet access to its people, Brunsch said.

The availability of solutions to problems and the potential for rural communities to meet the challenges that existed before and that have popped up during the pandemic was a consistent theme during the News Watch town hall. All four panelists said they were confident that small towns would survive the pandemic and that there was potential to come out of it stronger than when they went in.

"People are working together, becoming closer, realizing the importance of community and family and getting back to what's important in our lives," Anderberg said. "And I really think that seeing the support not only for my business, but just as a neighbor, I just think everybody is gonna come out of it stronger. And so that's my hope. That's the way I feel."

ORDINANCE #167

AN ORDINANCE TO AMEND TITLE 4 ZONING, CHAPTER 4.33 RURAL ADDRESSING,

SECOND REVISION BROWN COUNTY ORDINANCES, AS AMENDED

BE IT ORDAINED by the Brown County Commission, Brown County, South Dakota, that the Second Revision Brown County Ordinances, shall be amended as follows:

CHAPTER 4.33..... RURAL ADDRESSING

4.3301 Naming of Roads in the unincorporated area of Brown County, South Dakota, (excluding areas of joint jurisdiction being: one (1) mile of Groton, one (1) mile of Hecla, one-half (1/2) mile of Frederick, and one and one-half (1 1/2) miles of Warner City limits; and also including the incorporated communities of Claremont, Columbia and Stratford):

The names of roads are hereby fixed and adopted in accordance with and as shown by the official road address maps of the county. The names on these maps shall supersede the road names found on the plats recorded in the office of County Register of Deeds. The County Planner is directed to submit the necessary documentation to attach changes to the plats to correspond with the names on the official road maps of the county.

The County Planner will name or approve the naming of all future roads in accordance with South Dakota Administrative Rules Chapter 50:02:03 except as specified below.

4.3302 Installation and Maintenance of Road Intersection Signs in the Unincorporated Area:

The County Highway Department shall maintain installed signs at designated county road intersections.

When new roads are platted, whether public or private, the owner or developer shall install or reimburse the County or Township Authority for all material and labor costs associated with the installation of intersection signs.

Sign material and location shall be specified by the Highway Superintendent.

All installation costs shall be determined by the Highway Superintendent.

Townships shall install and maintain intersection signs within their unincorporated towns.

4.3303 Designation of Addresses in Brown County:

Addresses for buildings along all public and private roads in Brown County shall be issued by the County Addressing Administrator except for inside city limits of Aberdeen, in accordance with South Dakota Administrative Rules Chapter 50:02:03 except as specified below.

The County Addressing Administrator shall keep a record of all numbers assigned according to this ordinance and forward a copy to the Register of Deeds, Assessor's Office, Treasurer's Office, GIS Office, E-911 Communications, Auditor's Office, City of Aberdeen Fire Chief, Emergency Management (for rural fire departments), local utility companies, Townships (of the assigned area), USPS, and one letter sent by standard mail to the owner of the parcel.

Addressing both sides of the following roads and in an area outside the City Limits of Aberdeen bordered by the following roads may be an exception to Brown County rural addressing numbers using two (2), three (3), four (4) or five (5) digit address numbers corresponding with similar addressing conventions of the City of Aberdeen working outward from Main Street and Railroad Avenue from City Limits to:

North – 130 Street
East – 392 Avenue
South 136 Street
West – 385 Avenue

Addressing inside the City Limits of Groton working outward from Broadway Street, Railroad Ave on the east side of Broadway Street and following the Railroad Line on the west side of Broadway Street.

Addressing both sides of the following roads and in an area outside the City Limits of Groton bordered by the following roads may be an exception to Brown County rural addressing numbers using two (2), three (3), four (4)

or five (5) digit address numbers corresponding with similar addressing conventions of the City of Groton working outward from Broadway Street, Railroad Ave on the east side of Broadway Street and following the Railroad Line on the west side of Broadway Street:

North – 132 Street
East – 408 Avenue
South – Willow Ave (W&E of South Broadway St)

West – 404 Avenue
4.3304 Posting of Designated Addresses in the Unincorporated Areas:

The owner or occupant or person in charge of any house or building to which an address has been assigned will be notified by the County Addressing Administrator of the address assigned to the same at any time after the adoption of this ordinance.

Within sixty (60) days after the receipt of such notification from the County Addressing Administrator, the owner or occupant or person in charge of the structure to which an address has been assigned shall affix the address to the structure, if visible from the road, or to a sign or number post if not visible from the road, in such a way that the address can be clearly seen from the roadway.

It shall be the duty of such owner or occupant or person in charge thereof upon affixing the new number to remove any different number which might be mistaken for, or confused with, the number assigned to said structure by the County Addressing Administrator.

Each principal building shall display the address assigned to the frontage on which the front entrance is located. In case a principal building is occupied by more than one business or family dwelling unit, each separate dwelling or unit must display a separate address.

Mobile homes located in an organized mobile home park must display their proper lot number on the mobile home lot visible from the driveway/access way.

Address characters shall be painted or applied, of contrasting color to the background, of not less than three inches (3") in height.

If a building or dwelling is situated in such a way that the address cannot be easily seen from the roadway in front of said structure, then a sign or address post must be used in front of the structure or at the entrance of the primary driveway and placed in such a way that it can easily be seen from the roadway.

4.3305 New Structures:
Addresses will be assigned to each proposed lot or tract on the surveyor's copies of final subdivision plats by the County Planner.

No building permit shall be issued for any principal building until the owner or developer has procured from the County, City or Township Addressing Administrator the official address of the premises. Final approval of a principal building erected or repaired after the effective date of this ordinance shall be withheld until permanent and proper addresses have been displayed in accordance with the requirements of paragraph 4.3304 above.

4.3306 Penalties:

In the event that the owner or occupant or person in charge of any house or building refuses to comply with the terms of this ordinance by failing to affix the address assigned within sixty (60) days after notification, or by failing to remove any old addresses affixed to such structure or primary driveway or elsewhere which may be confused or in conflict with the address assigned thereto within said sixty (60) day period, shall be guilty of a class 2 misdemeanor. Each day of non-compliance shall be a separate offense.

4.3307 Conflicting Ordinances:

All ordinances or parts of ordinances in conflict therewith are hereby repealed.
