Weekly Vikings Roundup Divisional Playoff Recap

Never in NFL history have three playoff games in the same weekend ended on last-second field goals. That is exactly what happened to the top-seeded Packers and Titans, as well as the defending champion Buccaneers. To top it off, the Chiefs need a last-second field goal to take their game into overtime.

It started on Saturday afternoon in Nashville. Despite being sacked nine times, Bengal quarterback Joe Burrow showed why he was the #1 pick in the 2020 draft. Burrow hung in there all day long, throwing for 348 yards. After a Titan turnover at mid-field late in the fourth quarter, Burrow hit his former college teammate JaMarr Chase on a 19-yard completion to set up the winning field goal. The comment of the day came from the Bengal rookie kicker Evan McPherson just before going out to hit the game-winning 52-yard field goal: he looked at Joe Burrow and said, "looks like we are going to the AFC Championship game". Final score: 19-16.

The late game on Saturday pitted the Green Bay Packers against the San Francisco 49ers. The Packers were the biggest favorite for the weekend and after marching the opening kickoff for a quick touchdown, it appeared the rout was on.

The Niners had to step up on defense to keep the game close and the game came down to special teams. While leading 7-0, Aaron Rodgers engineers a typical two-minute drive to end the half but the Niner's special teams blocked a field goal attempt as the half ended.

Late in the fourth quarter with the Packers punting from deep in their end, the Niner's unit comes through again to block a punt and run it in for the score to tie the game with just four minutes remaining, That was plenty of time for another ARodg late-game comeback but not this time. The Packers were forced to punt and the Niners needed to go 80-yards to try to win the game. Deebo Samuel leads the Niners down inside the 30-yard line and set up a Robbie Gould game-winning 44-yard field goal as time expired. Lambeau Field was silenced but the Skol chant could be heard at the Minnesota Wild game as the crowd learned of the outcome. Final score: 13-10.

Moving onto Sunday, the LA Rams go to Tampa Bay and end what may be Tom Brady's final game. The Rams led for most of the game only to let the Buccaneers tie it late. Matthew Stafford hits Cooper Kupp on two passes for 65-yards in the



Losing a good teacher

The Red Wing School District is losing a great teacher, someone I respect immensely—my brother. If you're lucky, you get someone in your life that inspires you, teaches you to think for yourself, challenges you, and helps steer you to a successful path. In Red Wing, MN, Scott Bender is one of those guys, so respected, one graduating class demanded that he, not some spit-polished corporate executive, give the commencement address.

As a kid, his nose was always buried in a book. He was a pretty

good football player, too. There were six kids, so the money wasn't there to put us through college. Scott joined the U.S. Army and was assigned to an intelligence outfit in West Germany before the wall fell. He had to learn Russian to do it. Two hitches. In return, Uncle Sam provided him an education that he could pass on. Nothing makes him happier than when a former student tells him how much he's impacted their life. It's happened many times. It will happen many more.

Finding a good fit wasn't easy at first because Scott taught Social Studies, and often that's considered a sluff class taught by coaches, but Scott didn't want to coach. He wanted to teach. Really teach. His class wasn't an automatic "A," and he caught all kinds of heat when he failed students who didn't do the work. He caught heat for teaching real history, real current events.

Each summer, his vacations centered around visits to historical sites where he could see the lay of the land and learn things that weren't in the textbooks, things he passed on to his students, things that didn't necessarily come with the rah-rah gloss of textbooks.

If I had to choose a word to describe him, it would be integrity, a lesson he absorbed at home. You do things honestly, ethically, and you stick to your guns. That's what drove him, not some agenda. Facts. Reality.

I've never known him to be a political animal, just an honest broker of the facts. When Donald Trump was elected, his class started a list of his crimes including his propensity to inflate his wealth to get loans and then deflating it to avoid taxes. He and his class called it long before the investigations began. Some parents refused to let their kids do the homework. I'm sure their report cards reflected that. It wasn't political for Scott, it was about reality. Facts.

He also got blowback for discussing the impact of religion on world history and current events, but how can you teach history without mentioning institutions that were often at the root of wars?

This year, the principal, his antagonist, took away his politics class, leading one mother to lament to Scott how disappointed she was that her younger kids wouldn't be able to take his class. It may have been the last straw.

There are many reasons the nation is experiencing a teacher shortage. Stress is a big one. Compensation is another. Scott once helped lead a teacher's strike over an impasse on health insurance. He certainly didn't need to. His army service qualified him for veterans benefits, but this was about supporting other teachers.

He was also a catalyst in an effort to change the name of Columbus Day to Chief Red Wing Day because the unvarnished truth is that Columbus was a cruel occupier, a mass murderer. Scott became the liaison between the City of Red Wing and the tribe, a high honor. Last summer, I visited the educational monument in Red Wing that celebrated Native American history, a monument that emerged from his efforts. He didn't do it alone, but I wonder if it would have happened without him.

He was in a local watering hole one day when a former student he didn't recognize at first bought him a beer. "Mr. Bender, when I was in seventh grade you said you were going to get rid of Columbus Day, and you did. Congratulations."

His superintendent was dumbfounded when Scott told him he was retiring at 59. "But we can't replace you," he said. "Mr. Bender is an institution in these halls." There's no changing his mind, though. "I'm a dinosaur," he told the superintendent, "and the meteor is streaking down."



Lana's Annals by Lana Greenfield

Greetings to you all! We have just finished legislative week 2. Session has begun rather slowly, but committees are starting to hear bills and will ramp up from now on.

As chair of the education committee, I invited Dr. Maher, executive director of the Board of Regents, as an informational guest. He gave us an overview of the status of our universities, and we now have a total enrollment of 35,542 enrolled (university students both full and part time). The help centers, called opportunity centers, have replaced diversity offices. This may not seem to be a gripping idea to the average reader, but it creates an avenue for all students who have questions about needs they have, not just critical care offices used by small groups of students who want to promote their own causes. I really am pleased as has been what I have promoted for about 2 years now.

Our committee also heard from SDSU President Dunn, who informed us about a new degree in concrete construction, which many businesses think is needed for our state. BHSU President Nichols also told us about a new forestry degree being offered at her university. I think these two programs may be great to add. I did ask them, though, if programs are added, are they also studying ones that are losing enrollment and should be eliminated. I was assured that this is mandated in SB55 and is being carefully researched.

I also invited Secretary of Education, TiffanySanderson, to our committee, and she gave us an overview of the findings of the 5 year teacher compensation review that met this summer and of which I was a member. It is no secret that there is a teacher shortage in every state in the nation. We did find that those who are education majors in SD is growing so that is encouraging. Statistics show that our average teacher salaries in South Dakota have increased by 22 per cent in the past five years and has made us second in the nations for rate of increase. We have an actual parity ranking of 45th in the nation even though we listed as 50th in pay. She also stated that the current average SD teacher salary plus benefits is 71,000 dollars. Now that said, we have many teachers at retirement age, so that average will inevitably drop as beginning, inexperienced teachers will come in at a lower base rate.

The bill of the week in our education committee was known as the "Moment of Silence,"HB1015. At the start, I thought it sounded like a good idea as it would give children a time of quiet and reflection to start the day, a time to take a breath. However, we committees are in place to listen to testimony. During that time, the chief testifier was asked what would happen if the teacher/school did not observe the moment of silence. We were told that if passed and enacted into a law, the school could be in jeopardy of accreditation status for violating that law. This became a great deal breaker for me. Would this be a good reason to close certain schools? I then began thinking about teachers. What about an instructor? If he/she was only observing this for 10 seconds rather than one minute (the bill said up to one minute) or forgot to do it a few mornings, could this become a part of a poor evaluation? Would the teacher possibly be fired for insubordination (this term is on teaching contracts)? Some readers may look at this as "a stretch of the bill." I look at it as "unintended consequences." Therefore, I honored the vote to send the bill to the 41st day, which killed the bill in committee.

In local government we listened to HB1076 which would allow certain communities to elect aldermen at large. Again, at first glance, I thought this may be a decent bill. After all, we small town people have a hard time getting people to run for aldermen, let alone confine that to a specific area. I did, however, find it questionable that the size of the town was set at less than 2000.. One would think a town of 1500, for example, would be able to at least one person from a designated ward to run for office or at least be compelled to step up. In committee an amendment, brought by the sponsor, now called for the magic number to be a town less than 3000. This told me that someone from some town in South Dakota looked at the bill ahead of time and wanted their town to be included. Possible red flag. I started thinking about towns, projects, fights over projects, etc. This bill could essentially create a monopoly where a group from one city block of town could get elected to the board to push some agenda for their area. It also could mean that 5 people from the same household could run! Again, a stretch? Well, it could happen. I think there should be a person from each area providing a cross section of each part of a city. If we are able to do this in my town of 180, a town of 2500 should be able to. I was one of the 4 "no" votes so now it will go to the floor for debate. Stay tuned.

I would encourage everyone to get online and listen to our committee meetings. Just go to South Dakota State Legislature and find the committee you wish to hear. I also invite you to come to Pierre to our capitol to testify on a bill or just to visit. We are no longer doing testimony by phone but our lrc or I can direct you how to get on zoom.

Glimpses From Greenfield 2022–Week 2

The second week of the 2022 Session found a number of legislators taking to meeting from remote locations because of COVID afflictions. Last Monday night, I swabbed my nose, and when the test yielded my results a few minutes later, I was greeted by bright pink and vivid blue lines. Immediately, I began planning to return to Clark where I quarantined the remainder of the week. On Tuesday, there were three of us in "COVID jail". On Wednesday, one of the Senators returned from his Week 1 quarantine, so only two of us "dialed it in" by meeting remotely. However, Thursday, we were back up to three, and by Friday, there were five Senators in COVID quarantine. Upon speaking with Representative Greenfield, I learned that a significant number of House members were also meeting from remote locations. Meeting remotely is only an option for those who are dealing with COVID, as we want to protect each other from being exposed to the virus, while not allowing people to abuse the remote option for other reasons. We maintain the outlook that if at all possible, people need to be at the Capitol in-person to meet with constituents who travel to Pierre to participate in the process. For any of you who I missed last week, please know that I would have been there if I could have been there. Also, to my 99- and 97-year-old grandparents who are learning for the first time that I had COVID last week, didn't want to worry you so I asked people not to tell you!

Although I was away, I was EXTREMELY BUSY via electronics. Appropriations met, both as a House/Senate Joint Committee, and in sub-groups appointed to deal with specific issues. One such group that I am the chairman of has been discussing options for addressing the sales tax rate. In 2016, when the additional one-half percent was imposed, there was an amendment put on the bill stating that we would systematically roll the tax rate back to 4% if-and-when we were allowed to impose sales tax on sales that took place through "remote" internet sellers. As you know, South Dakota argued successfully before the Supreme Court that all sales, whether on Main Street or through cyberspace should and could be treated the same. Now that the taxes are being equally applied, there is a focus on attempting to make good on that statute. In future weeks, I will apprise you of progress being made on the issue.

Another sub-committee I am chairing is looking at the processes we follow regarding allocating and expending the unprecedented amounts of federal tax dollars that continue to flow into SD due to COVID legislation passed by Congress. That group's work is in its infancy, as we have only had about an hour-and-a-half preliminary meeting. More to come on that front, as well.

Some of the issues we deal with in Pierre take on a much higher profile than others. Still other bills seek to "clean-up" problems and oversights that exist in current law. One such bill is SB 29 which seeks to delineate between regular motor vehicles and highway maintenance vehicles. It is not a glamorous issue, but it is a good example of how we attempt to clarify ambiguities that exist within the law whether they are brought up by bureaucrats or constituents. In this case, current law says that all motorists must abide by minimum speed limits on interstate highways. However, it does not provide for an exception for highway equipment operated by personnel performing maintenance duties. This is so common sense that it is surprising it ever came up. However, as they say, "Words have meaning." When a law sweeps EVERYBODY into the same category, it sometimes overlooks things. I say this as a reminder that if you have an issue that just "doesn't seem right", you should bring it up and see whether it is covered somewhere else, or if it needs to be addressed via legislation.

Another such issue that will be discussed in a future article was brought to my attention by Randy Angermeier who heads up the Clark Ambulance Service, as it relates to processes they follow and costs they incur because of our law. According to Randy, we are the only state in the Union who hasn't changed their law as new medical technologies allow for cost-savings, while not jeopardizing the safety of those they serve. Stay tuned in future

weeks as that issue works its way through the process. The most notable bill of the second week was SB 46, which the Governor brought forward to deal with the "women in sports" issue. This has gotten all kinds of attention over the past few years, so I will not go on at-length about it. I look at it from a safety and fairness perspective. Regarding safety, we acknowledge that certain individuals have physical attributes that would serve to put them at an advantage or disadvantage over others. One argument that had never crossed my mind until this weekend is that in SD for decades, the SDHSAA has required wrestlers to participate within certain weight groups. From time-to-time, you will hear of a youngster who doesn't meet the minimum weight for wrestling in the 106-pound division. On the flip-side, I remember when I was in school, one of my friends actually had to cut weight so he didn't exceed 285 pounds in order to wrestle Heavyweight. The policies are objective—dare I say, agnostic"—as to what the muscular attributes are of any of the kids participating. They simply assume it is reasonable to confine people to certain weight classifications, without allowing for somebody deemed too light or too heavy to participate until they achieve the minimum or maximum allowable weight. Again, the focus is on safety. On the fairness front, although not all boys or all girls are built the same, it stands to reason that biology dictates boys have increased heart, lung, and muscular capacities that will allow them certain advantages. If even one biological boy takes away opportunities from one biological girl, not to mention scholarship opportunities at the next lever, the spirit of Title IX is being subverted. I commend the Governor for her leadership on this issue. It cannot go unnoticed that because of what we have seen taking place as biological males have begun taking opportunities and accolades from biological females across the country, as well as the Governor taking a very active lead on this issue, last year's legislation passed the Senate 20-15, while this year's legislation passed the same body comprised of the same membership, 27-6, with 2 excused.

Until next time, please pray for continued health and wisdom for ALL those you care about. As a legislator, I covet the prayers of those who lift us up. Thank you. God's blessing to each of you.

Dear EarthTalk: What's up with all the debate lately as to the flow allowed in new showerheads? —Bill G., New York, NY

The shower is a place of rejuvenation and relaxation for many of us, but it is also a big water hog, accounting for roughly 17 percent of the average U.S. household's water usage. Of course, we use a lot less water in our showers nowadays thanks to a Clinton-era law mandating that new showerheads sold in the U.S. could not top a flow rate of 2.5 gallons per minute (GPM). While some showerhead manufacturers attempted to circumvent these new restrictions by utilizing multiple nozzles, the federal government eventually revised the legislation (in 2013) to limit entire fixtures to 2.5 GPM.

During his term in the White House, Donald Trump often complained about his dissatisfaction with the water pressure in his showers. In December 2020 Trump reversed the Obama-era amendment; this restored the federal limit of 2.5 GPM to be applied to individual nozzles instead of the entire fixture. This meant that a shower head with three nozzles would be permitted to



use 7.5 GPM.

Although Trump's law did not have a significant impact on the market demand for luxury shower heads, the loophole posed detrimental environmental impacts. Americans take about 200 million showers every day. The Alliance of Water Efficiency estimates that under Trump's rule the country's water usage would increase by 161 billion gallons per year. An increase in water usage also results in more energy use to heat that water, which in turn increases greenhouse gas

According to the U.S. Environmental Protection Agency Credit: pexels.com. (EPA), homes that have switched out older less efficient showerheads with newer models have realized savings of some 2,700 gallons of water per year. This equates to a savings of 330 kilowatt hours of electricity annually, which is enough to power an entire house for

11 days. The Natural Resources Defense Council (NRDC) estimates that the average American household stands to save \$500 per year on utility bills after switching to low-flow shower heads. The group estimates that the nationwide transition to lower flow showerheads now underway can generate annual savings of

Saving water by using a low-flow shower head is a great start, but if you're looking for more ways to maximize your impact, the EPA has a few suggestions. When it comes to appliances, making sure to fix leaks is one easy way to save water. Additionally, whenever you need to run your dishwasher or washing machine, make sure you are optimizing for water- and energy-efficiency by only running it with a full load. Lastly, landscaping is always a talking point when it comes to reducing residential water use. If you have a lawn, it is recommended to save water by replacing it with native plants that don't require additional watering. If you're not ready to part with your lawn, the EPA suggests keeping the grass two to three inches high to ensure the soil retains water, reducing the need for frequent watering.

The **Physician-Patient**

Last spring, I was at home washing my hands, and as I glanced up into the mirror, I noticed

something unusual. My bathroom light hit my neck just right as I swallowed and there it was: a prominent lump. I diagnosed myself with a thyroid nodule and wondered how I, a physician, had failed to notice this large protuberance before that moment.

Thyroid nodules are quite common. In some cases, they are noticed by the patient (like me) or are found on exam. In many cases they are found on accident when someone has an imaging test like a CT scan, MRI, or ultrasound, done for some other reason. The vast majority of thyroid nodules are benign, only five percent or less representing thyroid cancer.

Typically, if a thyroid nodule is found, thyroid labs and a formal thyroid ultrasound will be recommended. The size and characteristics of the nodule on the ultrasound helps to guide whether a fine needle aspiration (a type of biopsy) should be performed. Many nodules are fluid filled and small, which we know conveys almost no risk of being cancerous, so those can be watched without biopsy.

In my case the nodule was medium sized, two centimeters in diameter, and had slight irregularity such that it was "mildly suspicious" and did warrant biopsy. As a physician-patient awaiting my procedure, I knew that the data said my nodule was still very low risk of being cancerous, but I still had some anxiety about the worst-case scenario.

My colleague, a surgeon, performed my fine needle aspiration expertly the next month. The procedure was easy, done in the office with minimal discomfort. She drained out enough fluid that I no longer had a visible neck lump afterward. My results returned benign, a huge relief.

My thyroid nodule story is a typical one and leaves me with the following advice for others. If a nodule is characterized as benign on ultrasound, rest assured, as these guidelines are sound and based in excellent data. If your doctor recommends a biopsy, try not to lose too much sleep; the procedure is very tolerable, and still most nodules are benign.

I had the good fortune of knowing that even if my mass turned out to be cancer, most thyroid cancers have excellent cure rates. However, I am oddly grateful to have had a small taste of the health stress my patients deal with daily. I hope it improves my doctoring.
