# Questions arise over skating rink closure, proposed daycare center

Discussion of the city's ice skating rink closure took the stage early in Tuesday's Groton City Council meeting.

Chris Frost, who lives near the rink on West Third Avenue and Garfield Street, said he thinks the city is moving in the wrong direction by closing the ice rink at the end of January.

The city announced on Facebook that the rink would be closed for the season due to warm conditions.

It's the second year the city has closed the rink just after the Carnival of Silver Skates, Frost said, and it's a disservice to the community.

"If we continue to just have it open for two weeks and close it, we won't have a skating program," he said "Kids aren't going to know how to skate. ...And it gives kids something to do during the winter."

Frost volunteered to take over caring for the ice if the city could provide him a key to the warming house.

"I just feel like we give up on it way too soon," he said. "I'm volunteering my time to take care of it, make it smooth."

He pointed out that it doesn't seem flat as the center melts before the edges. And the more effort that is made to take care of the ice and get a good base in the area before flooding it, the better the conditions will be out there. It has been a tough year for the ice, said Mayor Scott Hanlon. "When it's cold, we always have it open because we have good ice,"

Northern recently received approval from the South Dakota Board

of Regents to start the bachelor's degree program, in order to address the critical workforce needs in the community, region and state. The program also received approval from the South Dakota Board of Nursing.

"I am very excited that Northern has hired Dr. Monson as our Associate Dean of Nursing to launch our BSN program. She has deep experience in the nursing field, in both the clinical and educational areas. Dr. Monson has a passion for nursing education in Aberdeen and this region of the state, having most recently served as a faculty member and the site coordinator for the SDSU accelerated nursing program on Northern's campus," said Provost and Vice President for Academic Affairs Dr. Mike Wanous.

Monson has 18 years of experience in academics and has been a nurse for 23 years. In addition to teaching, Monson works at Avera in the intensive care unit.

"I feel it is important to maintain an active practice to be an effective nurse leader and educator in a healthcare system that is continually changing," Monson said.

Monson earned her Doctorate of Nursing in 2022 from Northern Kentucky University, her

Master of Science in Nursing in 2014 from Western Governor's University and her Bachelor of Science in Nursing in 2001 from Presentation College. She is a registered nurse who holds certifications as both a certified critical care registered nurse and certified nurse educator.

Having lived in the Groton, S.D. area her whole life, Monson is invested in the region. She has two daughters, Hailey and Hannah. Hailey is following her mother's footsteps and is currently studying nursing at SDSU. Hannah is a senior in high school and also plans to go into nursing.

"This is a huge endeavor, but I enjoy confronting challenges with creative solutions, collaborative networking, and meticulous organization," Monson said. "The goal is to build a robust program through a multistep approach— this includes the creation of an innovative and comprehensive curriculum that supports the values of this community, reflects the mission of Northern, and aligns with accreditation standards," Monson said.

The new bachelor's degree will be housed in the soon-to-be-built Northern Business and Health Innovation Center. The BSN program will officially start Fall 2025, with the option for students to start their pre-nursing courses in Fall 2024. "The next steps will also include finalizing the building project, organizing clinical placements, securing final approval from regulatory bodies, and assembling qualified faculty and staff," Monson said.

The city won't be able to reopen the rink this season, though, said Wastewater Superintendent Dwight Zerr, as there was a sewer line collapse in that area just before the rink was closed for the season.

## Child care options discussed

Groton residents Keith Wipf and Charity Hinman approached the council Tuesday with a plan to build a child care center and teen center in town.

"We're in dire need," Wipf said.

Wipf asked the council to consider selling a piece of property south of the Community Center for the venture with a contract spelling out that his company Ringneck Construction, Inc. could not sell the land for a set amount of time and that it needed to become a day care facility.

Currently there isn't a state-licensed day care in Groton, Hinman told the council. Hinman had owned the last state-licensed facility, Teddy Bear Daycare, before selling the business in 2022.

A big problem with that business was the building it was housed in, she said. A new building would allow for a new child care facility and preschool.

Writer's note: I can't believe it's been 10 years. If you're struggling, dial 988, the suicide crisis hotline.

I once talked to a woman who had lost her

son. He must have been 15. Maybe 16. I don't remember. I will remember forever what she said between the silences that dominated the conversation, between the pauses that take measure of the pain.

"It was hard," she said. Simple, profound, starkly elegant, it was all that she could say, all that was necessarv.

Sunday morning, Julie appeared in the door-

way to my sanctuary as I was staring at my computer wondering what to write this week. In town, graduates were readying robes and tassels, preparing for life. School is out. Summer is here. Much-needed rain spawned lush green growth.

Quinn Trindle is dead," she told me. Joe Frazier in his prime could not have hit me harder. She read a Facebook post from Quinn's sister, Molly. It was suicide.

We looked at each other helplessly. Julie in the doorway, me in my chair, but really, on the floor, on the canvas. I think I moaned, but was otherwise incoherent. As if coherence has a place at times like this, with news like this. She closed the door slowly and left me alone.

We had mourned Quinn's loss to us years one mourned more than Dylan. Quinn was his best friend, the kind of friend every young boy should have-the kind you usually find devotion, epic in their loyalty and hugeness of heart. And these things Quinn Trindle was.

I do not know, cannot know, the inner workings of a friendship like that. These are sacred mysteries, known only to the boys who form these bonds. From the outside, it seemed they found each other through non-conformity. They each marched—meandered, really—to made sense only to them.

Quinn was a mighty wrestler. During Pee-Wee matches, he would wade through opponents, a wiry buzz saw of energy, and then he would cheer on Dylan, who had none of Quinn's acumen for the sport. The losses mounted for Dylan, but each time, after each defeat, Quinn would throw his arm around his friend and encourage him. "You're getting better," he would say.

It would have been easy for Dylan to resent the gold medals Quinn wore home from each meet. Easy for Quinn to move on to new friendships in the circle of winners. Neither of them were wired that way.

In February, Quinn finished second in the Montana State Wrestling Tournament at 135 pounds.

Pat and Joan were our friends, free-thinking, funny, cantankerous and wise. When they left it was a loss, a void as vast as the 700 miles between us, that can never be filled. But, for Dylan, it was much harder. Friends like Quinn Trindle come along just once in a lifetime, if ever.

Who can know what causes a boy to end his life before it has really begun. Is it possible to be so beloved and not know it?

A friend posted this on Facebook: "Alright buddy, I'm going to write one last goodbye... I'll miss you bro, from all the good times, to the gossip and all the plans we had... You were my closest friend, I don't think I could tell anyone half the stuff I've told you... and I'll miss all the times we shared... all the stupid stuff we've done, all the smart stuff we've done... Oh, and one other thing... we're keeping your spot in the Bro Circle warm... Love you, man... Rest in peace..."

His girlfriend wrote, "R.I.P., my beloved. I will never forget all the amazing times we've had together. I will never stop loving you. You are my one and only love. You are my first love and we've had a love that will always last. I wish I could have told you I love you a lot more."

I stared at the blurry computer screen. I







Council members asked about financial figures and making sure the cost of having a child in the day care would be manageable.

"I would hate to see this fail," said Councilman Jason Wambach. "There's a lot of kids in town, and if you had a day care facility it would be more attractive to move here."

Mayor Scott Hanlon agreed.

"We need a day care. Bottom line," he said. "We should see if we can get something going."

Councilman Kevin Nehls asked for the city to put the idea out to the community to see if there are any conflicts and if the proposed location on the lot south of the Community Center would be a workable spot.

## City contracting for new online bill program

There may soon be a new way to pay.

The City Council approved contracting with a new company that would handle online utility bill and other fee payments.

The web-based software, Payment Service Network, is compatible with the city's utility software, and residents will be able to log in to see their bills, what they've paid in the past and billing history, said Assistant Finance Officer Kellie Locke. They will still have credit card and E-Check fees similar to what is in place now, but it would be an easier system to use and will save money for the city.

It may take up to six weeks for the new system to be put in place once a contract is signed.

 While initial appearing to go up, cost adjustments on a new park saferoom/bathroom are set to lower what the city will pay for the new tornado shelter. Dear EarthTalk: What is so-called New Denialism all about? -- Paul C., Baltimore, MD

For years, human-induced climate change has been a controversial topic, despite heaps of scientific evidence proving its existence. In the past, climate change deniers have used the rhetoric of simply denying that climate change was happening. New denialism is different because instead of focusing on the existence of climate change, it attacks the policies meant to combat global warming, denies the benefits of clean energy, and targets scientists and advocates pushing for change.

Early in 2024, the Center for Countering Digital Hate, or the CCDH, published on YouTube an analysis of online discourse studying the frequency of different types of climate denial. The CCDH is a nonprofit organization whose mission is to "protect human rights and civil liberties." They do this by holding social media companies accountable for the content they publish. The CCDH's study, The New Climate Denial, found evidence suggesting that the outright dismissal of climate change is no longer convincing, so deniers are instead shifting the argument away from blatantly denying climate change to denigrating solutions like the transition to clean energy.

The CCDH study found that new denial content now makes up 70 percent of all climate denial claims that are posted on YouTube, a significant rise from the 35 percent in 2018. Claims that climate solutions won't work have also risen a significant amount over the same time frame, from 9 percent to 30 percent. YouTube as a host for this new denialism is especially worrying as it targets younger ages who could impact climate action decisions for the future.

Google, YouTube's parent company, has policies in place which are supposed to block advertising money from content that rejects scientific certainties about the existent and causes of climate change. This should prevent YouTube creators spreading disinformation from monetizing on their content. The CCDH report claims that these policies are ineffective and that YouTube is potentially making up to \$13.4 million



per year from ads on videos containing climate denial. This is an issue of company PR, because it's doubtful that many companies would want their advertising linked to climate denialism.

The fact is, scientists who study Earth systems have agreed for decades that the burning of fossil fuels creates an imbalance of heat-trapping gasses in the atmosphere that are continually warming the world.



A recent report from the Center for Countering Digital Hate (CCDH) found evidence suggesting that climate deniers are shifting the argument away from blatantly denying climate change to denigrating solutions like the transition to clean energy.

The warming causes melting ice, which in turn causes sea levels to rise. It also creates a host of other problems. New denialism has only started to become prominent because of the overwhelming evidence of climate change. Instead of fighting against well-known evidence, new denialism turns to discredit lesser-known solutions. By picking at clean energy solutions that are less established, new denialism continues to create doubt and delay the decisive actions that need to be taken to combat climate change.

## "These Boots Are Made For Walking"

Winter weather has finally arrived this year. Getting outside for some activity, even in winter, is great for your overall health. However snow, ice, and cold can turn a stroll in the park into an obstacle course. Having proper footwear is not only important for warmth,



but also the wellbeing of your feet. Choosing the correct boots for the elements could mean the difference between enjoying the outdoors and needing an urgent care visit. What makes good footwear for enjoying the outdoors safely?

Good traction is essential for walking outside in slippery conditions. If your shoes do not have good traction, you can buy ice cleat attachments. However, you likely already have something in your home that will help with increasing traction on icy sidewalks. The New Zealand Medical Journal published a study showing a significant improvement in traction by placing socks over normal footwear. In the study, those who wore socks over their shoes found walking on a hillside footpath less slippery and had increased confidence. You may look silly, but you are less likely to slip.

Having proper fitting shoes is also important when going outside. Shoes that are too tight could decrease circulation; leading to swelling of the feet and ankles. If they are too small, it can lead to ingrown toenails, corns, and calluses. Conversely, boots that are too loose can cause friction leading to blisters. Ill-fitting shoes can have poor arch support causing shin pain when walking. One might also be at higher risk for jamming a toe or spraining an ankle due to tripping or falling caused by improper fitting shoes. Additionally having shoes that keep your feet warm and dry are crucial in the winter. Frostbite occurs most commonly in extremities, such as fingers, toes, or the nose. The first signs of frostbite are a pins and needles sensation, throbbing, or aching in the affected areas. Trench foot has similar symptoms, but is caused by feet being in a wet environment for a prolonged period of time. Wet socks and wet boots can lead to both of these injuries. It is important to dry out boots between uses and have clean, dry socks when going outside in the winter. Having boots with weatherproofing and insulation will also help prevent these issues from occurring. Now that you know what "Boots are Made for Walking" and whether you are "Walking on Sunshine," "Walking in Memphis," or just want to "Walk the Line". The proper winter boots will keep you upright and safe. We would not want you to fall and have anyone else "walk all over you." So stay safe, get outside and stay healthy out there.
